

Commence at the northwest corner of the SE4 of SE4, Se ction 14, T 22 S, R 1 W and run south along the west boundary line of said quarter quarter section a distance of 22.0 feet to a point on the northeast 40 foot right of way line of Project CP1-145; thence run in a southeasterly direction along said northeast 40 foot right of way line along a curve to the right (concave southwesterly) and having a radius of 858.51 feet a distance of 146.0 feet to a point 40 feet left of P. T. Station 285+37.6; thence run S 52° 24'E along said northeast 40 foot right of way line a distance of 528.0 feet to a point on the west property line of said grantor; thence run southwesterly along said west property line a distance of 11.0 feet to the point of beginning on the northeast 30 foot right of way line of said project; thence run S 52° 24'E along said right of way line a distance of 147.0 feet to a point 30.0 feet left of P.C. Station 292+17.4; thence run in a southeasterly direction along a curve to the left (concave northeasterly) and having a radius of 1402.30 feet a distance of 16.0 feet to a point on the east property line of said grantor; thence run south along said east property line a distance of 36.0 feet to a point in the center of the present dirt road; thence run in a northwesterly direction along the center of said dirt road a distance of 165.0 feet to a point on the west property line of said grantor; thence run north along said west property line a distance of 41.0 feet to the point of beginning.

Said parcel of land is lying in the SE% of SE%, Section 14, T 22 S, R 1 W and contains 0.11 acre, more or less, including that part now occupied by the present dirt road.



To Have and To Hold by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged. All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
