the Act of Congress of the 21st of April, 1820, entitled "An Act making further provision for the sale of the Public Lands," for the South West quarter of the South West quarter of Section two, in Township twenty, of Range two East, in the District of lands subject to sale at *Uniontown*, Alabama, containing forty acres and eighteen and three fourths hundredths of an acre

according to the official plat of the survey of the said Lands, returned to the General Land Office by the SURVEYOR GENERAL, which said tract has been purchased by the said *Elisha Turner*

NOW KNOW YE, That the

United States of America, in consideration of the Premises, and in conformity with the several acts of Congress, in such case made and provided, HAVE GIVEN AND GRANTED, and by these presents DO GIVE AND GRANT, unto the said *Elisha Turner*

and to *his* heirs, the said tract above described: TO HAVE AND TO HOLD the same, together with all the rights, privileges, immunities, and appurtenances of whatsoever nature, thereunto belonging, unto the said *Elisha Turner*

and to *his* heirs and assigns forever.
