I, Carrie Lee Busby, a resident of Birmingham, in said County, in said State, being of sound mind and disposing memory, and being over the age of twenty one years, do hereby make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all wills at any time heretofore made by me.

FIRST

I direct that all of my just debts, including the expense of my last illness and funeral, shall first be paid out of my estate by my Executrix, hereinafter named, as soon after my death as may by her be found convenient.

SECOND

I give, devise and bequeath to my niece, Lela Mae Vardaman, a life estate for and during her natural life in and to all of my property real, personal and mixed of whatsoever kind and character and wheresoever situated, of which I shall die seized and possessed or to which I may be entitled at my death. My said niece, Lela Mae Vardaman shall have, use and expend all or any part of my property as may be necessary for her convenience, health, comfort and well being so long as she lives.

THIRD

I give, devise and bequeath to my two nieces, namely, Lessie Vardaman Lovett and Agnes Vardaman Davis, a life estate for and during their natural lives in and to all the rest, residue and remainder of my property real, personal and mixed of whatsoever kind and character and wheresoever situated of which I shall die seized and possessed or to which I may be entitled at my death and/or the proceeds therefrom not expended or disposed of by my niece, Lela Mae Vardaman, under the provisions of paragraph SECOND above. Said rest, residue and remainder of my property shall be divided equally between my nieces, Lessie Vardaman Lovett and Agnes Vardaman Davis, as of the day of the date of the death of the said Lela Mae Vardaman. Each of my said nieces shall have,

use and expend all or any part of my said property coming into her possession under and by virtue of the provisions of this paragraph as may be necessary for her convenience, health, comfort and well being so long as she lives.

FOURTH

I give, devise and bequeath to my great niece, Ida Kay Lovett, all the rest, residue and remainder of the undivided one-half interest in and to my said property devised and bequeathed to my niece, Lessie Vardaman Lovett, for and during her natural life in paragraph THIRD above, not expended or disposed of by my said niece, Lessie Vardaman Lovett, who is the mother of my said great niece, Ida Kay Lovett.

I give, devise and bequeath to my great niece, Beverly Jane Davis, all the rest, residue and remainder of the undivided one-half interest in and to my said property devised and bequeathed to my niece, Agnes Vardaman Davis, for and during her natural life in Paragraph THIRD above, not expended or disposed of by my said niece, Agnes Vardaman Davis, who is the mother of my said great niece, Beverly Jane Davis.

In the event that either of my said nieces, Lessie Vardaman Lovett or Agnes Vardaman Davis, shall predecease me, then, in that event, that part of my property that said deceased niece would have received a life estate in and to if living, shall go to and vest in her said daughter to whom the remainder is devised and bequeathed in this paragraph, to be hers absolutely without condition or restriction.

FIFTH

I hereby nominate, constitute and appoint my niece, Lela Mae Vardaman, as the Executrix of this my Last Will and Testament, and it is my will that she be not required to make bond or make or file any inventory or report of her acts as such Executrix.
