

I am familiar with a 12 acre tract owned by Lorraine Franklin and I know the same was taken off the Southwest corner of the above described land. Said Franklin lot is in the SWH of SWH of NWH of said Section 18 and is further described as being 260 ft. square. I also know that Frank Doss died several years ago. There is a house on said Carter land and Frank Doss lived in it and my husband put the ; wiring in said house. He had a garden plot and he used it each/year until he sold it to B.
