DECLARATION OF VACATION OF A CERTAIN ALLEY  
WITHIN THE TOWN OF CALERA, ALABAMA

WHEREAS, T. W. Lawrence and wife, Pauline Lawrence, John L. Davis and wife, Elizabeth V. Davis, are the owners of all property abutting the hereinafter described alley, as same appears on Dunstan's Map of the Town of Calera, Alabama, and which map shows the location of said alley herein described;

WHEREAS, the above parties is desirous of vacating said alley as same appears on said plat and which said alley is described as follows:

A part of a 20 foot alley extending Southerly through the middle of Block 27 according to said map which said alley is more particularly described as follows: Commence at the NE corner of Lot 21, Block 27 and run thence Southerly along the East boundaries of Lots 21 through 29, inclusive, to the North boundary of 12th Avenue; thence Easterly along the North boundary of 12th Avenue to the SW corner of Lot No. 1; thence Northerly along the West boundaries of Lots 1, 2, 3, and 4 to a point due East of the NE corner of said Lot 21; thence West 20 feet to a point of beginning.

NOW, THEREFORE, the undersigned, does hereby declare that the portion of that certain alley described above be vacated.

WHEREAS, the above mentioned parties, does hereby, pursuant to and in accordance with the provisions of Section 32 of Title 37, Code of Alabama 1940 as Recompiled, execute this written declaration of vacation of said alley, the same being within the limits of the Town of Calera, Alabama, a municipality, and does hereby pray and request the assent of the Mayor and Council of the Town of Calera, Alabama, to said vacation of said alley and its approval of same.

Such vacation will not deprive other property owners of a convenient and reasonable means of ingress and egress to their property.
