AMENDMENT TO RESTRICTIVE COVENANTS  
NAVAJO HILLS---THIRD SECTOR

WHEREAS, the undersigned are the owners of all lots as shown on map of Navajo Hills, Third Sector, which is recorded in the Probate Office of Shelby County, Alabama, in Map Book 5 page 56 in the Probate Office of Shelby County, Alabama,

WHEREAS, the undersigned are desirous of amending the restrictions and limitations applicable to all lots owned by said persons in said survey.

NOW, THEREFORE, the undersigned do hereby amend the Restrictions for Navajo Hills, Third Sector which are recorded in Deed Book 263 page 231 in the Probate Office of Shelby County, Alabama, by deleting therefrom paragraph number 8 therein and inserting in lieu thereof, the following paragraphs, to-wit:

"8. The ground floor area of the main structure, exclusive of one story open porches, breezeways, carports and terraces shall not be less than 1500 square feet.

8.a. Fences may be constructed to the rear of the dwelling house, but none shall be constructed nearer the front of the lot than the rearmost portion of any dwelling house."

In all other respects said Restrictions for Navajo Hills, Third Sector recorded in Deed Book 263 page 231 in said Probate Office shall remain unchanged and in full force and effect.
