RELEASE.

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations to the undersigned J.O. Dorroh, in hand paid by Carl W. Street and Kathryn Street, the receipt whereof is expressly acknowledged, I, the said J.O. Dorroh, do hereby release and discharge from the lien and effect of that certain mortgage made to me by Carl W. Street and Kathryn Street, dated January 31, 1969, and recorded in Mortgage Record Volume 310, page 681, et seq. in the Probate Office of Shelby County, Alabama, the following described real property, viz:

From the Southeast corner of Section 15, Township 19, South, Range 2, West, run Northerly along the East boundary of said Section 15 (15) for 227.59 feet, to the point of beginning of the land hereby released, thence continue Northerly along the East boundary of Section 15 for 120 feet; thence turn an angle of 86 degrees, 26 minutes to the left and run Northwesterly 288.74 feet; thence turn an angle of 93 degrees, 34 minutes to the left and run Southerly 120 feet; thence turn an angle of 86 degrees, 26 minutes to the left and run Southeasterly 287.69 feet, more or less, to the point of beginning.

It being understood and agreed between the parties, that this release is given under the following express condition, viz: That said mortgage shall be and remain a valid first mortgage lien against all of the other real property conveyed therein and not heretofore released.

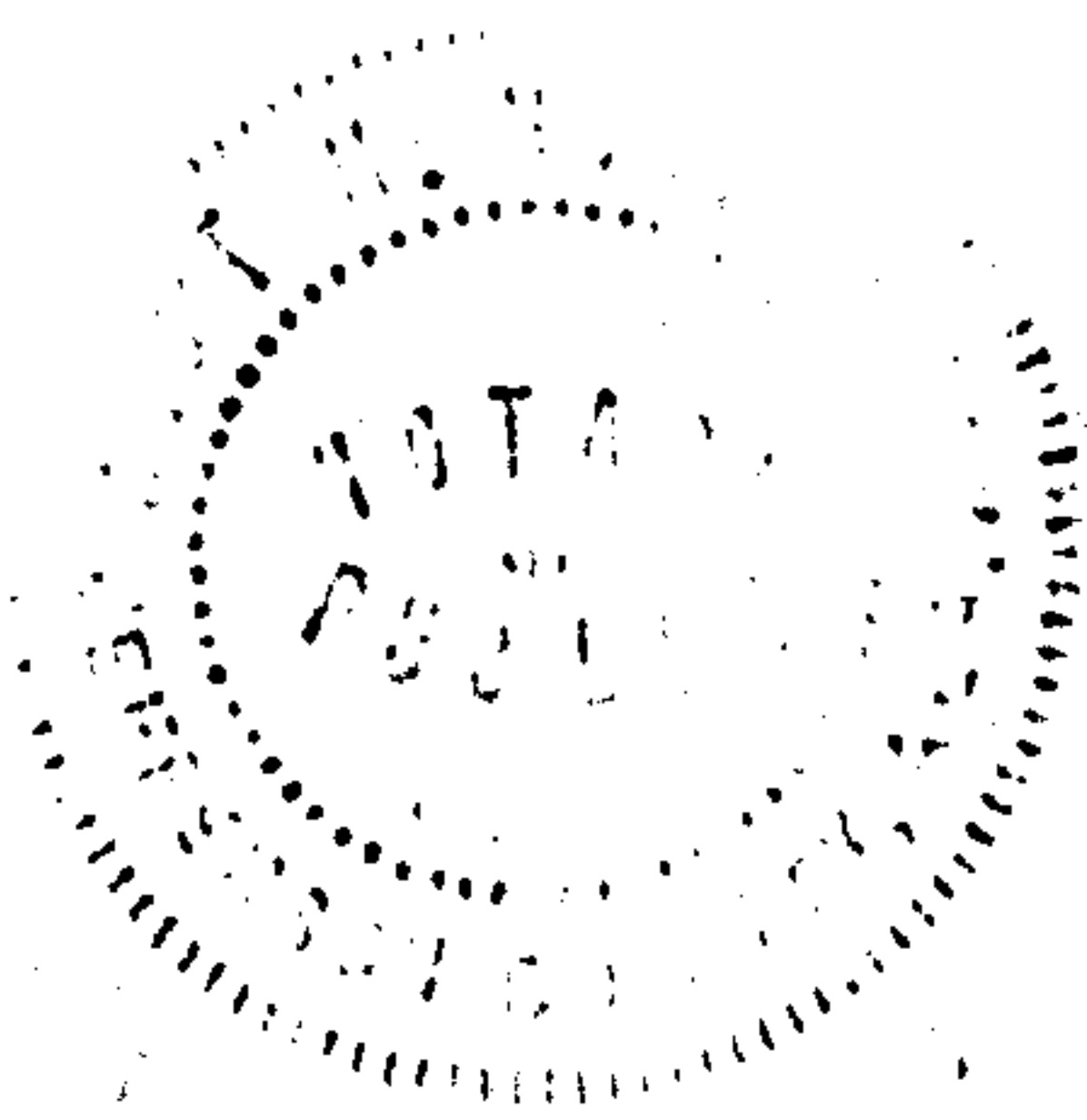
