(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated

in Shelby County, Alabama to-wit:

A lot of land situated in the NW¹/₄ of NE¹/₄ of Section 30, Township 19, Range 1 East, more particularly described as follows: Commence at a point where the West boundary of said Quarter Quarter Section intersects the North right of way line of U. S. Highway No. 280 and run thence North along the West line of said Quarter Quarter Section a distance of 264 feet for point of beginning; thence continue Northerly along the West boundary of said Quarter Quarter Section to a point 380 feet South of the NW corner of said Quarter Quarter Section and which point is on the South boundary of the Chelsea Game Preserve property; thence Easterly and parallel with the North boundary of said Quarter Quarter Section, and along the South boundary of said Game Preserve property 165 feet to a point; thence South and parallel with the West boundary of said Quarter Quarter Section to a point 318.5 feet North of the intersection of said last mentioned line, if extended, with the North right of way of U.
