The following resolution was introduced and upon motion duly made and seconded said resolution was unanimously adopted:

That the Indian Springs Development Corporation shall have the authority to borrow money from Jefferson Federal Savings & Loan Association for the development of a mobile home park located on U.S. Highway 31, South of Birmingham and further described as: Lot 1 in J. H. Barker's Survey of part of the NW% of SW% of Section 6, Township 20, Range 2 West and NE% of SE% of section 1, Township 20, Range 3 West, according to Map thereof recorded in Probate Office of Shelby County, Alabama and described as follows: Commence where the West line of the right of way of the Birmingham-Montgomery Highway intersects the North line of the NW% of SW% of Section 6, Township 20, Range 2 West, thence southerly along the West line of said right of way 339.14 feet; thence 90 deg. to right 812.73 feet to North line of the NE% of SE% of Section 1, Township 20, Range 3 West; thence East 881.47 feet to point of beginning.

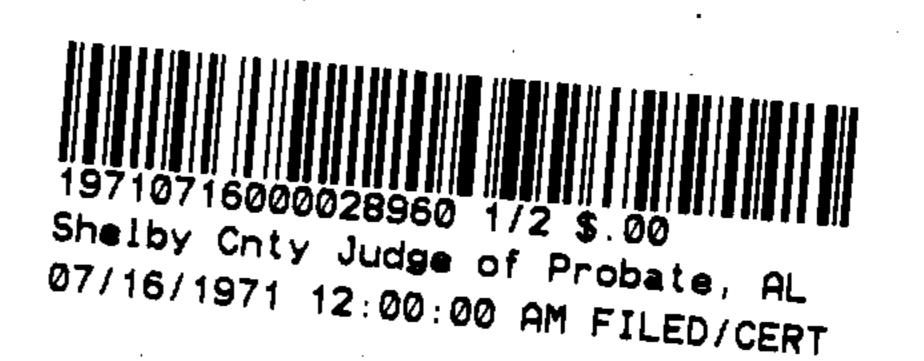
EXCEPTING right of way of 4 lane Birmingham-Montgomery Highway.

Also all that part of the SE% of NE% of Section 1, Township 20, Range 3 West, lying SE of a straight line drawn from the SW corner to the NE corner of said SE% of NE%, except that part of said 20 acres described as follows: Begin where the South line of Lot 1 in J. H. Barker's Survey intersects the South line of the SE% of the NE% of Section 1, Township 20, Range 3

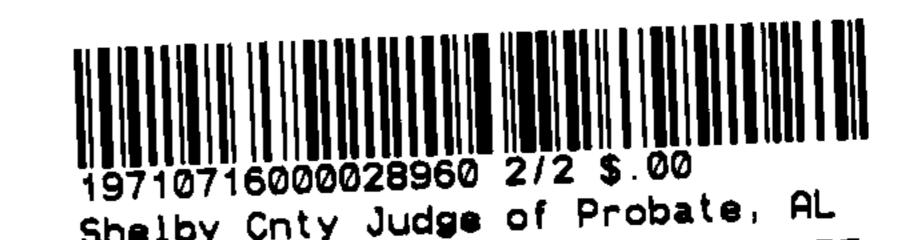

West, thence along the said line of said Lot 1 extended in a Northwesterly direction to its intersection with the center of Bishop Creek, as shown on map of J. H. The sum to be \$215,000.00. The three directors agreeto sign the mortgage and to be responsible for an equal third of said mortgage by personal endorsement.
