Commence at the Southwest corner of Section 18, Township 20 South, Range 2 West; run thence in a Northerly direction along the West line of said section for a distance of 1100.24 feet; thence turn an angle to the right of 89 degrees 50 minutes 30 seconds and in an Easterly direction for a distance of 193.84 feet to the point of beginning; from point of beginning thus obtained thence continue along last described course for a distance of 170 feet; thence turn an angle to the left of 86 degrees 37 minutes and in a Northerly direction for a distance of 175.47 feet; thence turn an angle to the left of 84 degrees 58 minutes (said angle being measured from last described course to the chord of the preceding course, said course being situated on a curve having a central angle of 10 degrees 04 minutes and a radius of 351.63 feet); thence run along the arc of said curve for a distance 61.78 feet to the end of said curve; thence along the tangent, if extended, to said curve in a Westerly direction for a distance of 35.55 feet to the point of beginning of a curve to the left (said curve having a central angle of 33 degrees 33 minutes 30 seconds and a radius of 25.0 feet); thence along the arc of said curve for a distance of 14.64 feet to a point of reverse curve (preceding curve having a central angle of 34 degrees 40 minutes 15 seconds and a radius of 35 feet); thence along the arc of said curve for a distance of 21.18 feet; thence turn an angle to the left of 72 degrees 39 minutes 52¹/₂ seconds (said angle being measured from chord of last described course to the preceding course) and run in a Southwesterly direction for a distance of 196.94 feet to the point of beginning.
