in hand paid by Industrial-Home Builders, Inc.

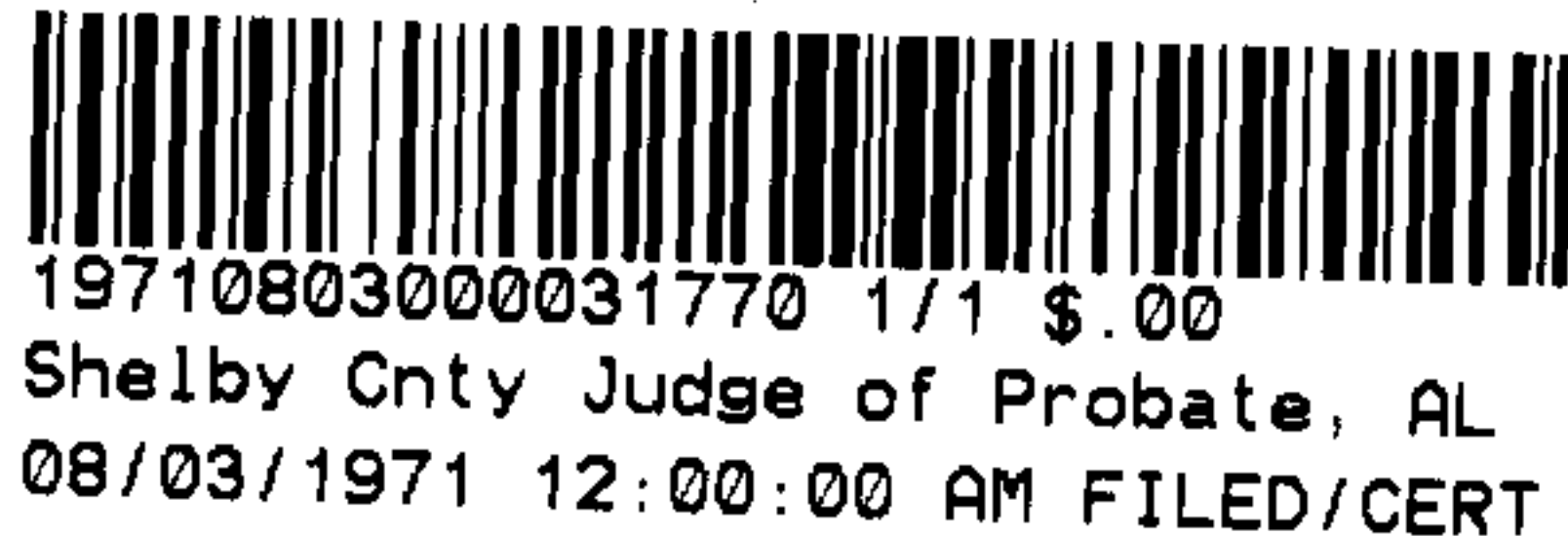
the receipt of which is hereby acknowledged, the said Cahaba Valley Homes, Inc.
