CHANGE OF NAME OF CHURCH

We the undersigned, Ronny Robbins, C. L. Reach, and Catherine V. Fancher being all the trustees of Southside Baptist Church, an incorporated church, which has been in some instances heretofore designated as "Southside Baptist Church of Montevallo", "Southside Baptist Church, a corporation, Montevallo, Alabama", "Southside Baptist Church, Montevallo, Alabama" and "The Southside Baptist Church" certify that the official name of said church is and has been "Southside Baptist Church", said church having been heretofore organized<sup>and</sup>/existing under the laws of the state of Alabama, the corporate charter of said church being recorded in corporation record #9 at pages 246-251, Office of Judge of Probate of Shelby County, Alabama.

That<sup>the</sup>/official name of said corporation, as set forth in the certificate of incorporation of said church, as shown on page 246 of corporation book 9 in said Probate Office is mistaken in that the name of said church as set forth therein is "Southside Baptist Church, a corporation, Montevallo, Alabama", whereas the name of said church should have been and was intended to have been set forth as "Southside Baptist Church", the words "a corporation, Montevallo, Alabama" not having been intended to be a part of the official name of said church.

That<sup>at</sup>/a meeting of the membership of the said Southside Baptist Church, the said religious corporation, held on the 22nd day of August, 1971, at the regular meeting place of said church in Montevallo, Shelby County, Alabama, after notice of said meeting had first been given, as provided by law, the name of said corporation was officially established and changed to "Southside Baptist Church" by a resolution unanimously adopted by the membership of said religious corporation, and it was further resolved that the undersigned trustees of said church shall do all things necessary to effect

uate the changing of the name of said corporation to Southside Baptist Church;

1. The name of said corporation is Southside Baptist Church;
2. The certificate of incorporation of said corporation was originally filed in the Office of the Judge of Probate of Shelby County, Alabama, on , to-wit, March 18, 1971, in Corporation Record 9 at pages 246-251;
3. The name of said corporation, if it was ever other than "Southside Baptist Church" is changed now to "Southside Baptist Church".

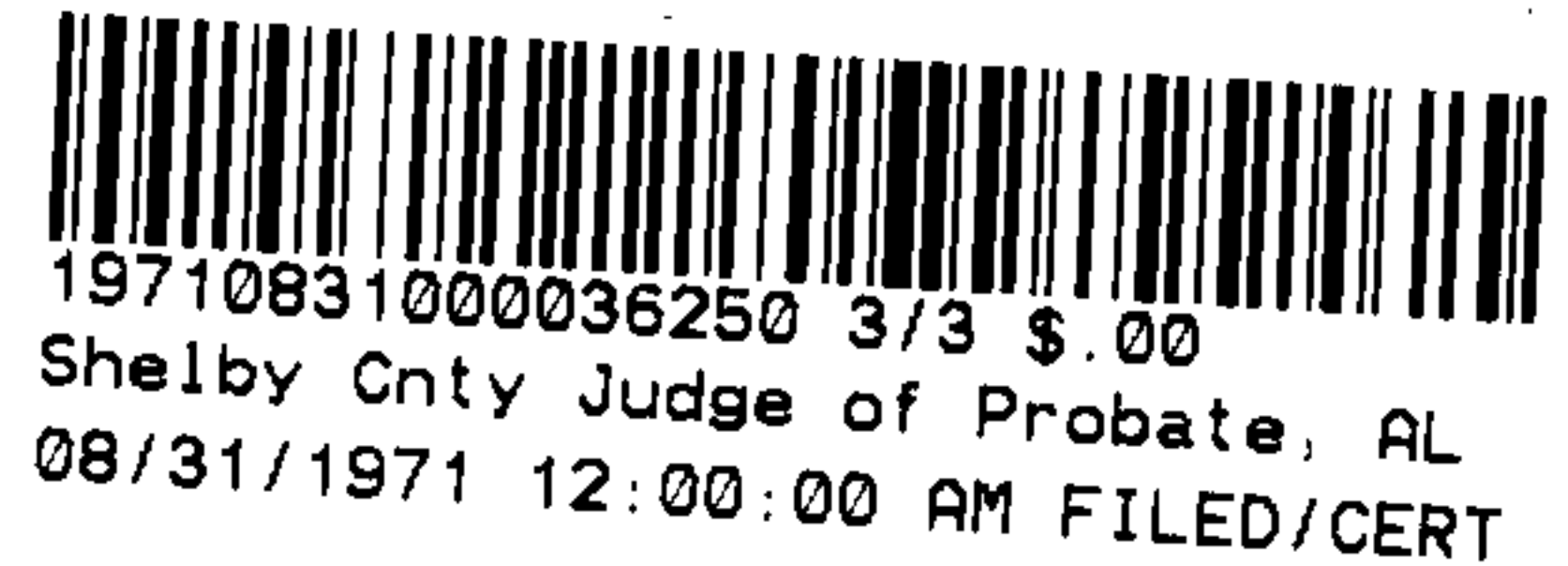

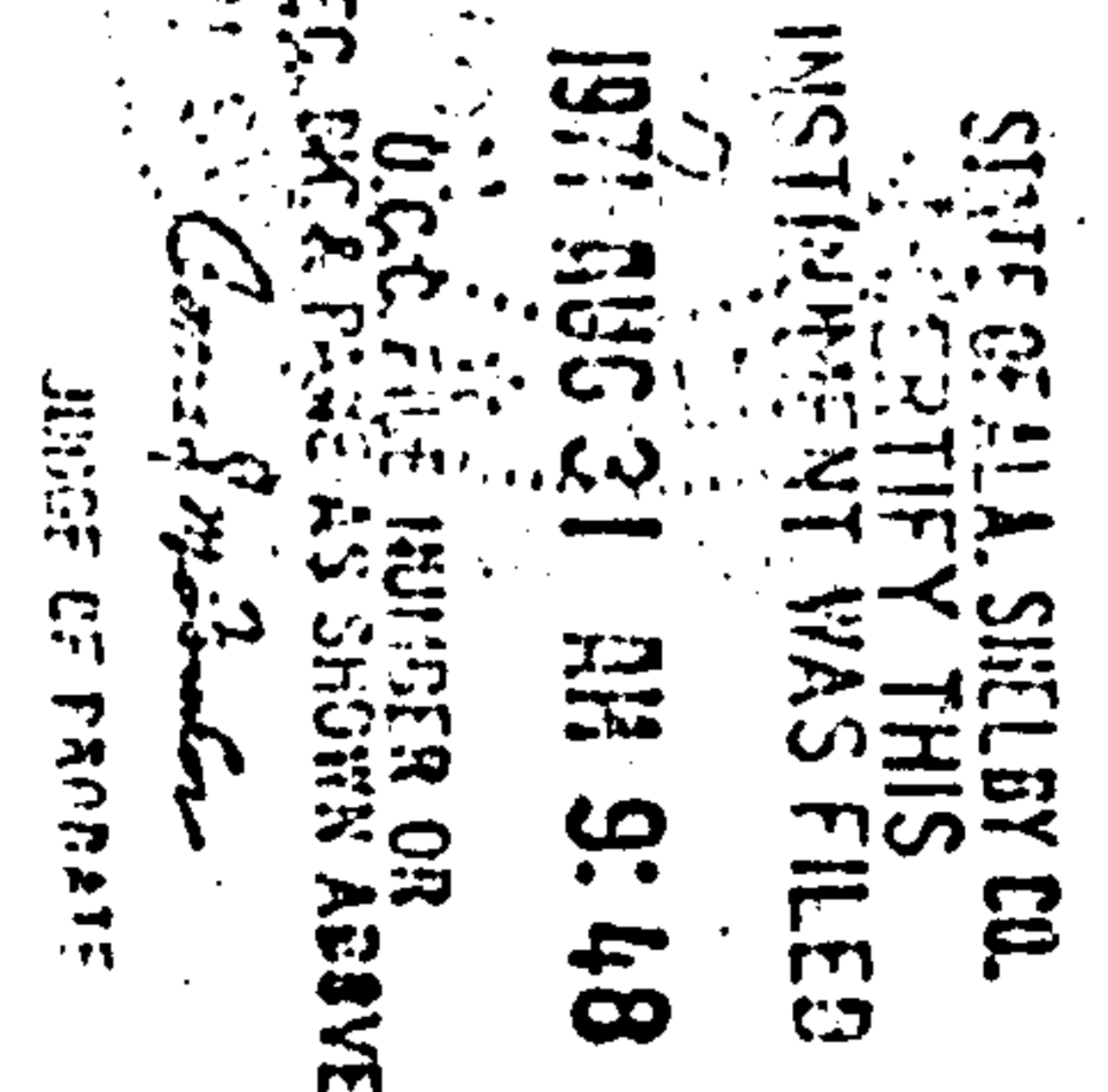
