

KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of One Dollar (\$1.00) and other valuable considerations, to the undersigned grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged we, S. M. Smith and wife Florence Smith, James S. Smith and Jessie Dean Smith, (herein referred to as grantors), do grant, bargain, sell and convey unto Arlon Smith, also known as Obie A. Smith, and wife Louise Smith, (herein referred to as Grantees), for and during their join lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in St. Clair County, Alabama, to-wit:

An undivided two-thirds (2/3) interest in and to the following described property:

Commence at the Northeast corner of the Southwest Quarter of the Northwest Quarter of Section 6, Tp. 18, Range 3 East; thence in a Northwesterly direction along the land line of Willie Johnson to an iron stake on top of mountain, being a made corner between the lands of Arlon Smith, Coosa River Newsprint Company and Willie Johnson and said corner being in the Southeast Quarter of the Northwest Quarter of the Northwest Quarter of Section 6, Township 18, Range 3 East; thence North 45 degrees West 7.0 chains to creek; thence meandering along creek South 60 degrees West 5.14 chains: thence South 40 degrees West 2.91 chains; thence South 65 degrees West 2.00 chains to West line of the Northwest Quarter of the Northwest Quarter, Section 6; thence South 6.00 chains to Southwest corner of the Northwest Quarter of the Northwest Quarter of Section 6; thence South 10.26 chains to the top of the mountain; thence meandering and along the top of the mountain South 29 degrees West 9.22 chains; thence South 23 degrees West 4.00 chains; thence South 26 degrees West 7.77 chains; thence South 30 degrees West 4.14 chains; thence South 37 degrees West 4.39 chains; thence South 26 degrees West 3.70 chains; thence South 32 degrees West 5.60 chains; thence South 33 degrees West 6.45 chains; thence South 34 degrees West 4.85 chains; thence South 40 degrees West 4.61 chains; thence South 43 degrees West 2.64 chains; thence South 31 chains West 4.91 chains to a made corner on the North line of the $NW_a^{\frac{1}{4}}$ of the NE¹/₄ Section 12, Tp. 18, South, Range 2 East, Shelby County, Alabama. This made corner being 14.22 chains West of the Northeast corner of the NWa of the NE% of said section; thence East along the North line of Section 12 to the Northeast corner of said Section;

It is the intention of Grantors to convey to Grantees all their right, title, interest and claim in and to the above described property.


