KNOW ALL MEN BY THESE PRESENTS: That in consideration of ONE DOLLAR and other good and valuable consideration to the undersigned grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we Claude Partridge and wife Mary Partridge; Margie P. Carr and husband Douglas Carr; Melba P. Whitehead and husband Raymond Whitehead; Shirley P. Kelley and husband William Kelley; Mary Jo P. Brasher and husband Johnny Brasher; Jerry Wayne Partridge and wife Billie Kate Partridge (herein referred to as grantors) do grant, bargain, sell and convey unto Joseph J. Vickers and Peggy J. Vickers (herein referred to as GRANTEES) for and during their joint lives upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

A lot or parcel of land described as follows: Start at the southwest corner of the Northeast quarter of the Southwest quarter of Section 11, Township 18 South, Range 1, East, run north 296 feet along quarter line to point of beginning; thence north along quarter line 210 feet; thence east 439 feet; thence southwest 210 feet; thence west 347 feet to point of beginning, containing two (2) acres more, or less, being situated in the Northeast quarter of the Southwest quarter of Section 11, Township 18 South, Range 1, East, Shelby County, Alabama.

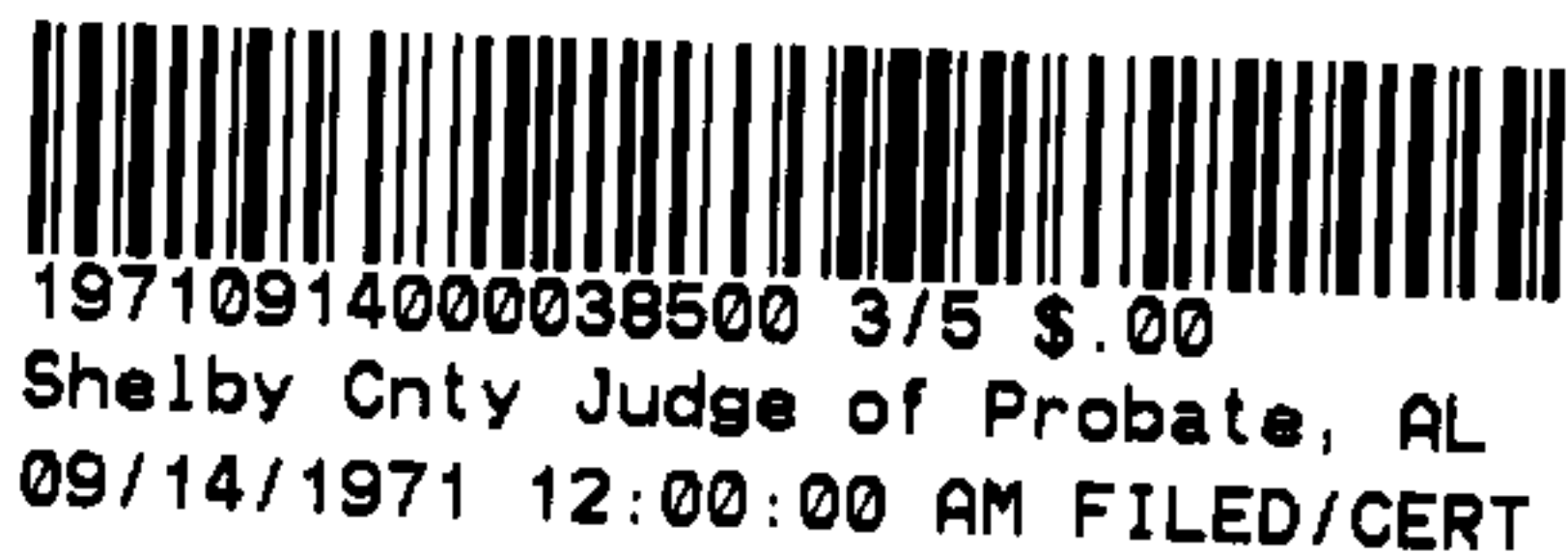

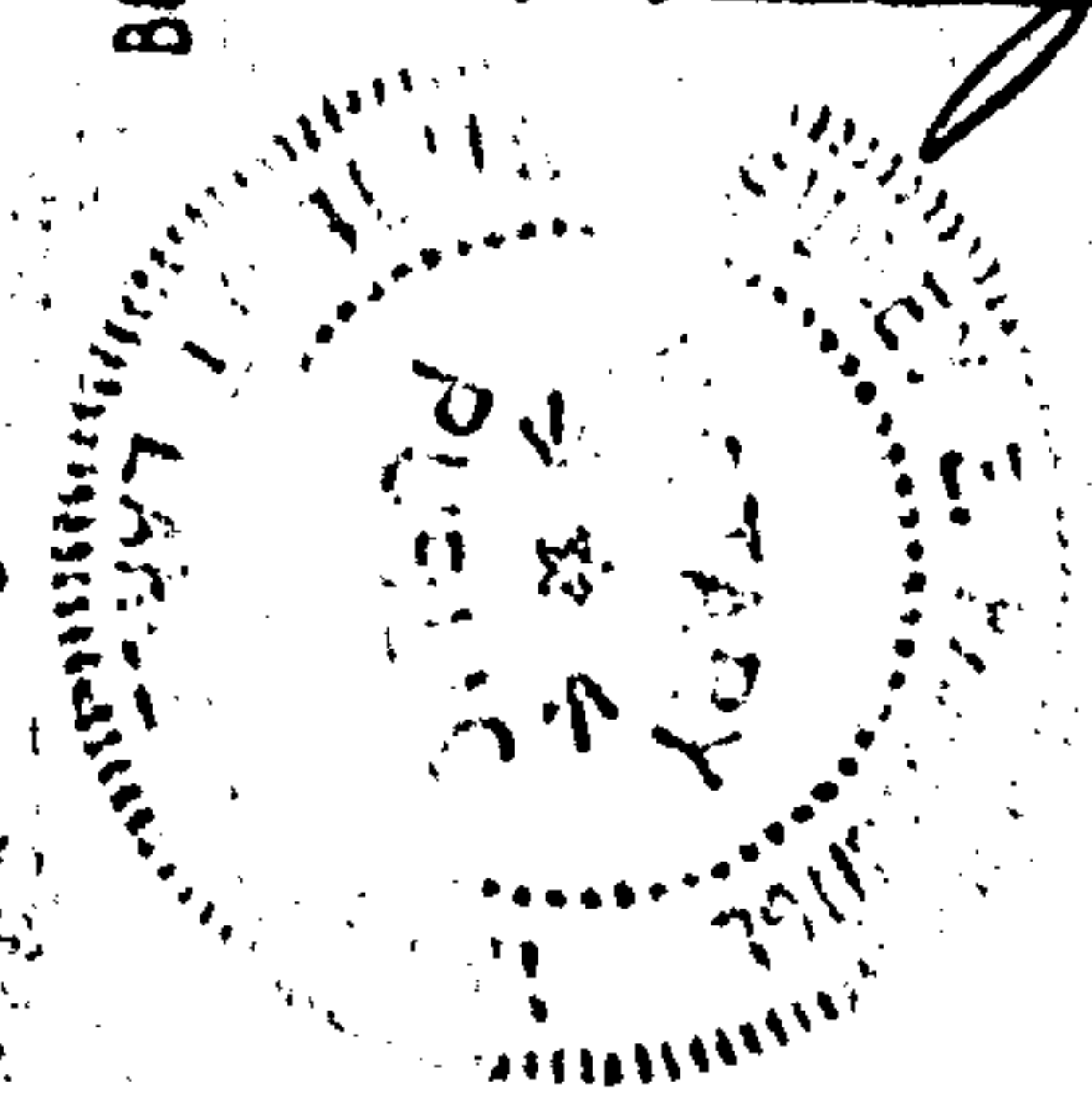
