

DEED TO REAL ESTATE EXCLUSIVE OF BUILDING

STATE OF ALABAMA }
MONTGOMERY COUNTY }

1976

THIS INDENTURE, made and entered into, this 1 day of September 19 71
by and between the State of Alabama, party of the first part, and Sam Spates, Mancil Garrett and
Klein Baptist Church, and their successors in office, Thomas Logan, Trustees of the
party of the second part, witnesseth that whereas it has been decided by the State of Alabama not to use
the hereinafter described lands for school purposes as set out in the deed conveying the same to the State;
and whereas the Board of Education of Shelby County has certified to
Dr. LeRoy Brown as Superintendent of Education
of the State of Alabama, that it is for the benefit of the public school interest of District 15
School Klein, Shelby County, that said lands be sold.

AND WHEREAS, the State Superintendent of Education, with the approval of the Governor, has ne-
gotiated this sale under the provision of Code 1940, Title 52, Section 373, and whereas it has been certified
by the State Superintendent of Education to the Governor, that this sale has been obtained and nego-
tiated, and that all requirements of law with respect thereto have been complied with, and that such sale
is concurred in by the Governor as provided by Code of 1940, Title 47, Section 57.

NOW THEREFORE, for and in consideration of the premises and of the sum of \$ 1.00
paid by the party of the second part, receipt of which is hereby acknowledged, I

George C. Wallace

, as Governor of the State of Alabama, and I

Dr. LeRoy Brown

, as Superintendent of Education

of the State of Alabama, in pursuance of the authority conferred upon us by Code of 1940, Title 52, Sec-
tion 373, and Title 47, Section 57 do hereby for the State and in its name grant, bargain, quit-claim and
convey and by these presents have granted, bargained, quit-claimed and conveyed unto the party of the
second part all of the right, title and interest of the State of Alabama in and to the following described
property, to-wit:

Commence at the SW corner of Sec. 16, T-20-S, R-2-E, thence run East along the South
line of Sec. 16, a distance of 2645.00 ft., to the SE corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of
Sec. 16, thence turn an angle of 113 deg. 39 min. to the left and run a distance of
805.80 ft., to the point of beginning, thence turn an angle of 24 deg. 18 min. to
the right and run a distance of 210.00 ft., to the South R.O.W. of Ala. Hwy. No. 76,
thence turn an angle of 110 deg. 52 min. to the left and run a distance of 121.09 to
a point on said R.O.W., thence turn an angle of 1 deg. 54 min. to the left and run
along said R.O.W. line, a distance of 298.80 ft., thence turn an angle of 67 deg.
14 min. to the left and run a distance of 210.00 ft., thence turn an angle of 112 deg.
13 min. to the left and run a distance of 419.84 ft., to the point of beginning.
Situated in the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Sec. 16, T-20-S, R-2-E, Shelby County, Alabama.
