Seventeen Thousand, Nine Hundred and No/100-----Dollars

the receipt whereof is acknowledged, the said Cardinal Enterprises, Inc.

does by these presents, grant, bargain, sell, and convey unto the said

as joint tenants, with right of survivorship, the following described real estate, situated in
Shelby County, Alabama, to-wit:

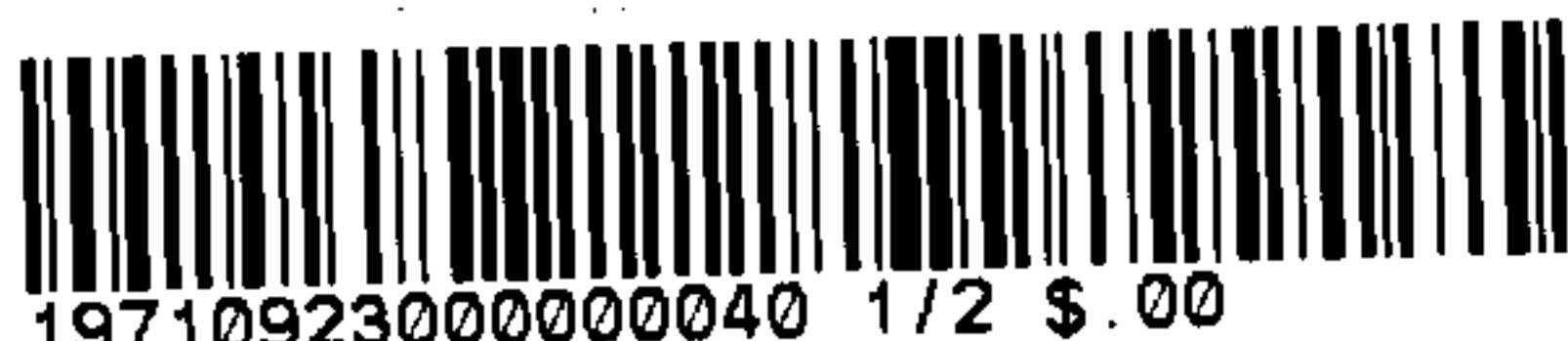
