Before me, the undersigned authority in and for said County in said State, personally appeared Wiley Hunt, who, after being by me first duly Eworn to speak the truth, deposes and says:

My name is Wiley Hunt. I am 68 years of age and live at 2364 East 88th Street, Cleveland, Ohio. My brother, Daniel Hunt, and I purchased the hereinafter described land on April 3, 1941, as shown by deed recorded in Deed Book 110, page 184, in the Probate Office of Shelby County, Alabama, said land being described as follows:

Five acres in the Southwest Corner of the NE% of SW% of Section 23, Township 21, Range 1 West, situated in Shelby County, Alabama.

I was born and raised in Columbiana, Alabama. My mother and father died many years ago without a Will and they had five children. They were: Wiley Hunt, affiant; Daniel Hunt, who died without a Will in December, 1970, and never married and had no children; Charlie Hunt, who married, but never had any children and died without a Will before Daniel Hunt died; Alonia Hunt, who died when he was still about 50 years ago a young boy and was never married and left no heirs; Johnny Hunt, who/ but they divorced many years ago. Johnny Hunt died and left and whose wife was Addie Hunt,/ three children, whose names are: Vera Hunt Ishman, a divorced woman; Juanita Hunt Donald, a divorced woman; and Johnny Hunt, Jr., unmarried, all of whom are over the age of 21 years and of sound mind. Affiant further says that affiant's father, Dan Hunt, and Mother, Emma Hunt, purchased said land as shown by deed dated July 31, 1909, as recorded in deed book 42, page 585 in the Probate Office of Shelby County, Alabama. Affiant further says his father died and gave the land to my mother before he died, some 56 years ago and the children all recognized said land as belonging to their mother and she lived on it until shortly before April, 1941, when she moved to Birmingham to live with affiant and deeded said land to Wiley Hunt and Daniel Hunt. She lived on it and had a garden and raised her family there. My brother and I went into immediate possession of it and rented it out to tenants until several years ago when the house was torn down. Since that time, we have assessed it each and every year until Daniel's death and since that time, I have been assessing it and paying taxes on it and I have had folks check on it from time to time to see that noone cuts the timber and I am in the possession of said property and
