WE, JOE A. SCOTCH, JR., & WIFE, MYRNA C. SCOTCH

for and in consideration of the sum of ONE & NO/100

_____ Dollars (\$ 1.00) to US in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over, under

and across the following described lands situated in SHELBY

County, Alabama:

BEGIN AT THE NE CORNER OF THE NW 1/4 OF SE 1/4 OF SECTION 11, TOWNSHIP 19 S, RANGE 3 WEST; THENCE WESTERLY ALONG THE NORTH LINE OF SAID QUARTER, QUARTER A DISTANCE OF 333.69 FEET; THENCE 90°00' LEFT FOR 250.0 FEET; THENCE 90°00' LEFT AND RUN 367.82 FEET; THENCE 49°09'50" LEFT FOR 347.73 FEET TO A POINT ON NORTH LINE OF QUARTER, QUARTER BEING THE NW 1/4 OF THE SW 1/4 OF SECTION 7, TOWNSHIP 19 S, RANGE 1 W; THENCE 134°58' LEFT AND ALONG THE NORTH LINE OF SAID QUARTER, QUARTER OF SECTION 166.31 FEET TO POINT OF BEGINNING.

THE ABOVE EASEMENT IS NOT TO EXCEED 15 FEET IN WIDTH AND IS TO CONFORM TO THE ATTACHED DRAWING WHICH IS TO MAKE A PART OF THIS CONVEYANCE AND RECORDED FOR THE ABOVE EASEMENT TO BE VALID. IT IS HEREBY UNDERSTOOD & AGREED THAT IF THE ABOVE POLES AND LINES OBSTRUCT FUTURE SUB-DIVISIONS AND/OR CONSTRUCTION ON ABOVE DESCRIBED PROPERTY, SAID POLES AND LINES WILL BE MOVED BY AND AT THE EXPENSE OF ALABAMA POWER COMPANY ONE TIME ONLY.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles, towers, and appliances on lands of grantors herein above described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or re-established from time to time.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.

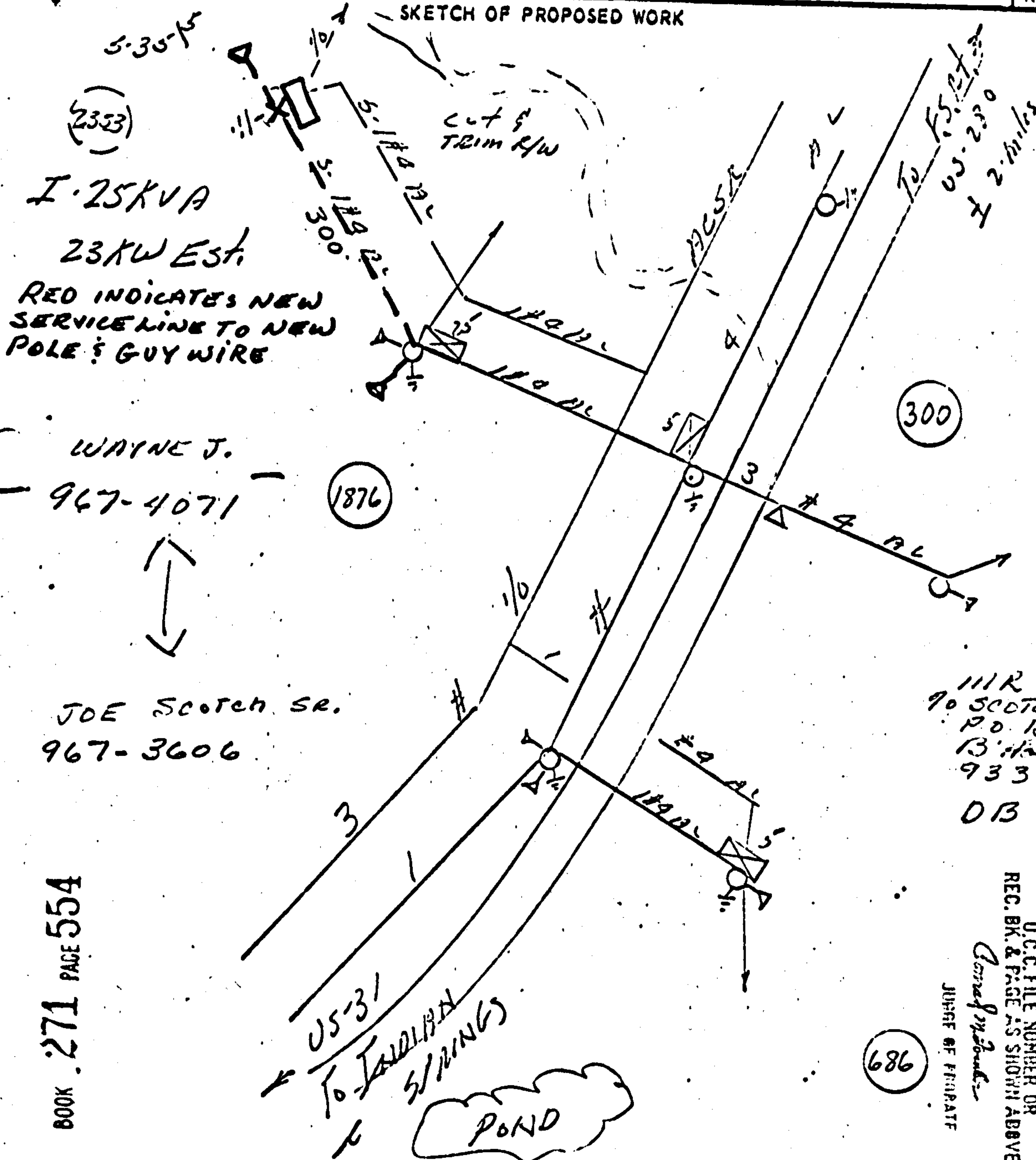
