

Commence at the northwest corner of the NW% of NE%, Section 19, T 22 S, R 1 W and run east along the ; north boundary line of said quarter quarter section a distance of 514.0 feet to the point of beginning on the southwest 40' right of way line of Project CP2-111; thence continue east along said north boundary line and crossing the centerline of said project at Station 234+37 a distance of 91.0 feet to a point on the northeast 40' right of way line of said project; thence run S 33° 15'E along said northeast 40' right of way line a distance of 926.0 feet to a point 40' right of P. T. Station 224+89.0; thence run southeasterly, along said northeast 40' right of way line along a curve to the right (concave southwesterly) and having a radius of 3859.72 feet a distance of 391.0 feet to a point in the center of present dirt road; thence run northwesterly along the center of said present dirt road a distance of 300 feet to a point on the southwest 40 foot right of way line of said project; thence run northwesterly along said southwest 40' right of way line along a curve to the left (concave southwesterly) and having a radius of 3779.72 feet a distance of 98.0 feet to a point 40' left of P.
