

RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, _____

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

_____ see below _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ see below _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particular described as follows, to-wit: And as shown on the right-of-way map of Project No. CP2-111 as recorded in the office of the Judge of Probate of Shelby County.

Commence at the northwest corner of the NW $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 19, T 22 S, R 1 W and run east along the ;north boundary line of said quarter quarter section a distance of 514.0 feet to the point of beginning on the southwest 40' right of way line of Project CP2-111; thence continue east along said north boundary line and crossing the centerline of said project at Station 234+37 a distance of 91.0 feet to a point on the northeast 40' right of way line of said project; thence run S 33° 15'E along said northeast 40' right of way line a distance of 926.0 feet to a point 40' right of P. T. Station 224+89.0; thence run southeasterly along said northeast 40' right of way line along a curve to the right (concave southwesterly) and having a radius of 3859.72 feet a distance of 391.0 feet to a point in the center of present dirt road; thence run northwesterly along the center of said present dirt road a distance of 300 feet to a point on the southwest 40 foot right of way line of said project; thence run northwesterly along said southwest 40' right of way line along a curve to the left (concave southwesterly) and having a radius of 3779.72 feet a distance of 98.0 feet to a point 40' left of P. T. Station 224+89.0; thence run N 33° 15'W along said southwest 40' right of way line a distance of 969.0 feet to the point of beginning.

Said parcel of land is lying in the NW $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 19, T 22 S, R 1 W and contains 2.11 acres, more or less, including that part now occupied by the present dirt road.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
