## RIGHT-OF-WAY DEED FOR PUBLIC ROAD

STATE OF ALABAMA

Shelby County

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, \_\_\_\_\_

\_\_\_\_\_ and wife \_\_\_\_\_ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be \_\_\_\_\_ see below \_\_\_\_\_ feet in width on \_\_\_\_\_ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a \_\_\_\_\_ see below \_\_\_\_\_ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project No. CP2-111 as recorded in the office of the Judge of Probate of Shelby County.

Commence at the northwest corner of the SE $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 18, T 22 S, R 1 W and run N 89°12'E a distance of 1147.8 feet to a point on the centerline of Project CP2-111 at Station 249+16.6; thence run N 34°46'W along said centerline a distance of 22.4 feet to the point of beginning on the north boundary line of said quarter quarter section; thence run east along said boundary line a distance of 48.0 feet to a point on the northeast 40 foot right of way line of said project; thence run S 34°46'E along said right of way line a distance of 309.0 feet to a point 40 feet right of P.T. Station 245+97.2 Back = P.T. Station 246+03.4 Ahead; thence run southeasterly along said right of way line along a curve to the right (concave southwesterly) and having a radius of 22958.31 feet a distance of 28.0 feet to a point on the east boundary of said quarter quarter section; thence run south along said east boundary line and crossing centerline of said project at Station 245+04 a distance of 150.0 feet to a point on the southwest 40 foot right of way line of said project; thence run northwesterly along said right of way line along a curve to the left (concave southwesterly) and having a radius of 22878.31 feet a distance of 155.0 feet to a point 40 feet left of P. T. Station 245+97.2 Back = P. T. Station 246+03.4 Ahead; thence run N 34°46'W along said right of way line a distance of 361.0 feet to a point on the north boundary line of said quarter quarter section; thence run east along said north boundary line a distance of 48.0 feet to the point of beginning.

Said parcel of land is lying in the SE $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 18, T 22 S, R 1 W and contains 0.80 acres, more or less.
