RIGHT-OF-WAY DEED FOR PUBLIC ROAD

STATE OF ALABAMA

Shelby County

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be see below _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularity described as follows, to-wit: And as shown on the right-of-way map of Project No CP3-110 as recorded in the office of the Judge of Probate of Shelby County.

Begin at the northeast corner of the SE $\frac{1}{4}$ of SW $\frac{1}{4}$, Section 26, T 20 S, R 3 W and run west along the north boundary of said quarter quarter section and crossing centerline of Project CP3-110 at Station 18+25 and at Station 8+68 a distance of 1137.3 feet to a point on the northwest 40 foot right of way line of said project; thence run in a southwesterly direction along said 40 foot right of way line along a curve to the left, concave southeasterly, and having a radius of 1472.39 feet a distance of 406 feet to a point 40 feet left of P. C. Station 3+30.0; thence run S 54°05'W along said right of way line a distance of 230.0 feet to a point 40 feet left of Station 1+00; thence run in a northwesterly direction along a flare a distance of 85 feet to a point on the northeast 60 foot right of way of Project CP3-144; thence run in a southeasterly direction a distance of 55 feet to a point on the northeast 40 foot right of way of said project CP3-144; thence run southeasterly along said right of way along a curve to the right, concave northeasterly, and having a radius of 1949.86 feet a distance of 164 feet to a point; thence run in a northeasterly direction along a flare a distance of 100 feet to a point 40 feet right of Station 1+00 of Project CP3-110; thence run N 54°05'E along said right of way a distance of 230.0 feet to a point 40 feet right of P. C. Station 3+30; thence run northeasterly along said right of way along a curve to the right, concave southeasterly, and having a radius of 1392.39 feet a distance of 848.52 feet to a point 40 feet right of P. T. Station 12+02.9; thence run N 89°00'E (Magnetic Bearing) along said right of way a distance of 18.3 feet to a point 40 feet right of P. C. Station 12+21.2; thence run southeasterly along said right of way along a curve to the right, concave southwesterly, and having a radius of 4543.66 feet a distance of 592.04 feet to a point 40 feet right of P. T. Station 18+18.5; thence run S 83°32'E (Magnetic Bearing) along said right of way a distance of 46 feet to a point on the east boundary of the SE $\frac{1}{4}$ of SW $\frac{1}{4}$, Section 26, T 20 S, R 3 W; thence run north along said east boundary and crossing centerline of said project at Station 18+54 a distance of 44 feet to the point of beginning.

Said parcel of land is lying in the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ and SW $\frac{1}{4}$ of SW $\frac{1}{4}$, Section 26, T 20 S, R 3 W and contains 1.92 acres, more or less.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
