RELEASE OF LIEN

WHEREAS, the title of Kimberly-Clark Corporation to the land hereinafter described is subject to the lien of the Third Supplemental Indenture dated as of May 31, 1962, between Kimberly-Clark Corporation, The Chase Manhattan Bank, as Original Trustee, and First National City Bank, as Trustee, supplementing the Indenture of Mortgage and Deed of Trust dated as of January 1, 1948, from Coosa River Newsprint Company to the Chase National Bank of the City of New York, as supplemented (such Indenture of Mortgage and Deed of Trust, as supplemented, including such Third Supplemental Indenture, hereinafter collectively called "the Indenture"); and

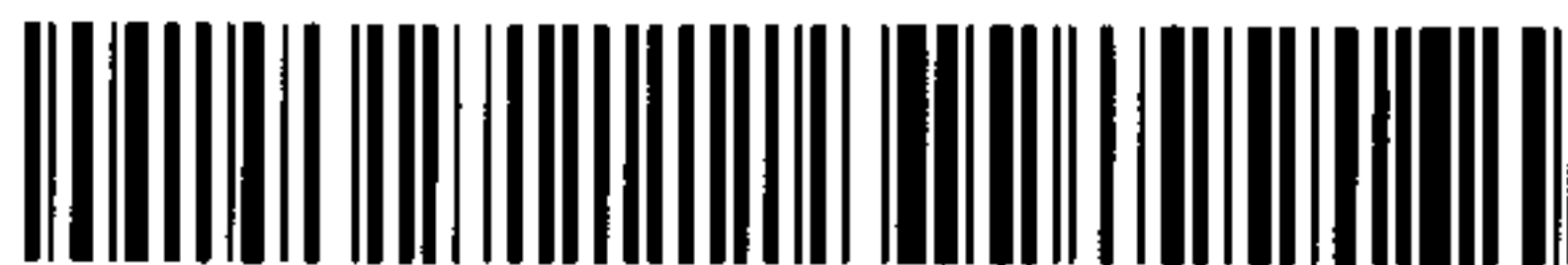
WHEREAS, Chemical Bank New York Trust Company, a corporation organized and existing under the laws of the State of New York, was, pursuant to an Instrument of Appointment and Conveyance dated August 15, 1967, appointed Trustee under the Indenture; and

WHEREAS, on February 17, 1969, Chemical Bank New York Trust Company merged into Chemical Bank, a corporation organized and existing under the laws of the State of New York, and Chemical Bank thereby became and is now Trustee under the Indenture; and

WHEREAS, pursuant to the provisions of Section 8.02(b) of the Indenture, Kimberly-Clark Corporation (hereinafter called "the Corporation") has requested the undersigned, as Trustee under the Indenture, to release such land from the lien of the Indenture and such other action has been taken in respect thereto as is required by the Indenture;

NOW, THEREFORE, Chemical Bank, as Trustee, under the authority of Section 8.03(b) of the Indenture, does hereby release and quitclaim from the lien of the Indenture of Mortgage and Deed of Trust dated as of January 1, 1948, as supplemented, all of its right, title and interest in and to the following described land:

The NE 1/4 of Section 32, Township 18 South, Range 1 East and the N 1/2 of the N 1/2 of Section 34, Township 18 South, Range 1 East, all in Shelby County, Alabama.

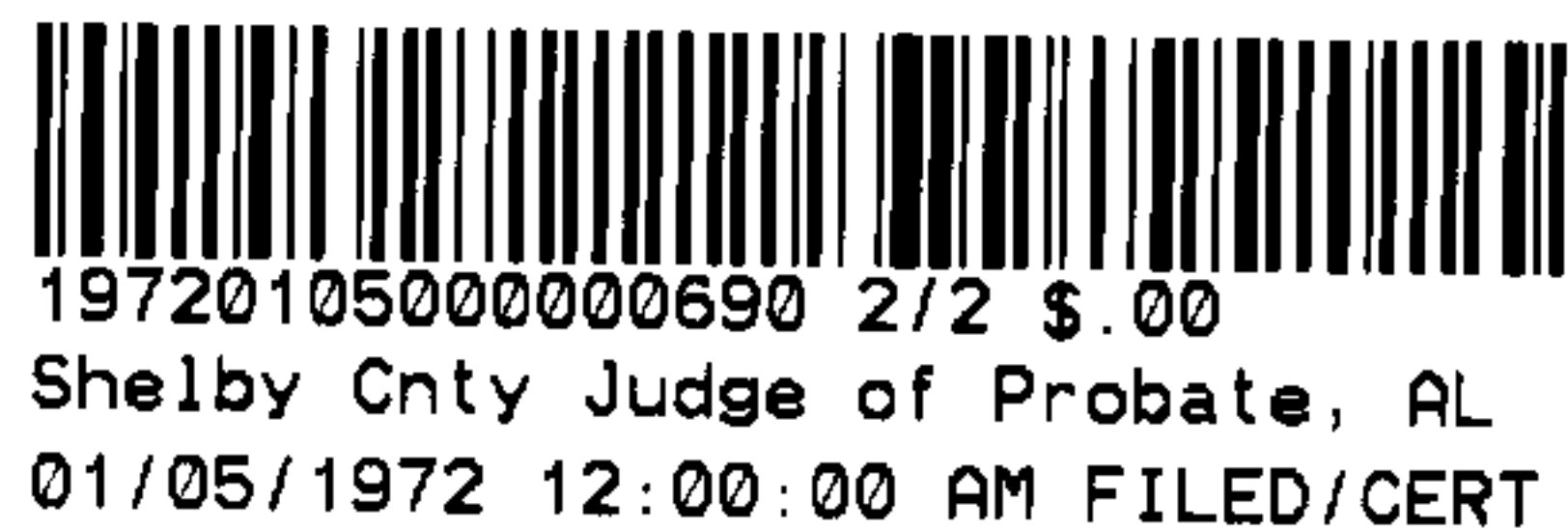
