RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be see below

_____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularity described as follows, to-wit: And as shown on the right-of-way map of Project No CP3-158 as recorded in the office of the Judge of Probate of Shelby County.

Begin at the southwest corner of the NW $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 27, T 20 S, R 3 W and run north along the west boundary of said grantor and crossing centerline of Project CP3-158 at Station 11+60 a distance of 990 feet to a point on the northeast 40 foot right of way line of said p oject; thence run southeasterly along said right of way along a curve to the right (concave southwesterly) and having a radius of 300.43 feet a distance of 189 feet to a point 40 feet left of P. T. Sta. 12+52.8; thence run S 0 $^{\circ}$ 51'E along said right of way a distance of 813 feet to a point on the south boundary of said grantor; thence run west along the said south boundary and crossing centerline at Station 20+65 a distance of 50 feet to the point of beginning.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
