

RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, _____

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

_____ see below _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ see below _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project NoCP2-111 as recorded in the office of the Judge of Probate of Shelby County.

Commence at the Northwest corner of the NW $\frac{1}{4}$ of SW $\frac{1}{4}$, Section 2, T 24 N, R 14 E and run south along the west line of said section a distance of 277.0 feet to the point of beginning on the Northwest 40' right of way line of Project CP2-111; thence continue south along said west line and crossing centerline at Station 87+33 a distance of 309.0 feet to a point on the southeast 40' right of way line of said project; thence run N 12°12'E (MB) along the said right of way line a distance of 1070.0 feet to a point 40' right of P. T. Station 78+09.0; thence continue along said right of way line along a curve to the left (concave northwesterly) and having a radius of 2904.79 feet a distance of 445.0 feet to a point on the north boundary line of said grantor; thence run in a northwesterly direction along the said boundary line and crossing centerline at Station 73+69 a distance of 80 feet to a point on the northwest 40' right of way line of said project; thence run in a southwesterly direction along a curve to the right (concave northwesterly) and having a radius of 2824.79 feet a distance of 440 feet to a point 40' left of P. T. Station 78+09.0; thence run S 12°12'W along the said right of way line a distance of 772.0 feet to the point of beginning.

Said parcel of land is lying in the NW $\frac{1}{4}$ of SW $\frac{1}{4}$ and SW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 2, T 24 N, R 14 E and contains 2.51 acres, more or less, including that part now occupied by the present dirt road.

All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
