RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, _____

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

see below _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a see below _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularity described as follows, to-wit: And as shown on the right-of-way map of Project No. CP3-144 as recorded in the office of the Judge of Probate of Shelby County. SPUR A

Commence at the southwest corner of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 27, T 20 S, R 3 W and run East along the south boundary line of said quarter quarter section a distance of 450.0 feet to the point of beginning on the southwest 40 foot right of way line of Project CP3-144; thence continue east along said boundary line and crossing the centerline at Station 33+85 a distance of 121.0 feet to a point on the northeast 40 foot right of way line of said project; thence run northwesterly along said right of way line along a curve to the right (concave northeasterly) and having a radius of 2824.79 feet a distance of 56.0 feet to a point 40.0 feet right of equation P.T. Station 33+95.1 Bk = P.T. Station 34+25.9 ahead; thence run N 48° 22' W along said right of way line a distance of 715.0 feet to a point on the west boundary line of said quarter quarter section; thence run south along said west boundary line and crossing centerline at Station 41+05 a distance of 106.0 feet to a point on the southwest 40 foot right of way line of said project; thence run S 48°22'W along said right of way line a distance of 608.0 feet to the point of beginning.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
