KNOW ALL MEN BY THESE PRESENTS, that REPUBLIC STEEL CORPORATION, a New Jersey corporation qualified to do business in the State of Alabama (hereinafter called "Grantor") for and in consideration of Ten Dollars (\$10.00) and other valuable considerations to it in hand paid by BURGESS MINING AND CONSTRUCTION CORPORATION, an Alabama corporation (hereinafter called "Grantee"), the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed and by these presents does grant, bargain, sell and convey, subject to all the terms, covenants, reservations, conditions and limitations hereinafter contained, to the said Grantee, its successors and assigns, the following described real property situated in Township 21 South, Range 5 West in the County of Shelby, State of Alabama, and more particularly described as follows:

Fee Simple

Section 11

The E 1/2 of the SE 1/4 excepting a part of a cemetery lot situated in the southwest corner thereof.

Section 12

The SW 1/4
The W 1/2 of the SE 1/4

Section 24

The NW 1/4 of the NW 1/4

Together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining.

SUBJECT TO all rights and privileges granted to the County of Shelby as set out in Instrument dated May 28, 1962 from Republic Steel Corporation;

SUBJECT TO all rights and privileges granted to Colonial Pipe Line Company as set out in Instruments dated April 26, 1963 and May 18, 1971 from Republic Steel Corporation;

SUBJECT ALSO TO all easements, covenants, reservations, restrictions, limitations and conditions of record and those that are visible upon the premises but not of record; zoning ordinances, if any; public highways; and all taxes and assessments, if any, due and payable after date hereof, which taxes and assessments the Grantee, by acceptance hereof, agrees to assume and pay.

This conveyance is made on the express condition that the Grantee for itself and on behalf of its successors, assigns, contractors, permittees, licensees, and lessees, by the acceptance hereof, releases and forever

discharges Grantor, its successors and assigns, from any and all liability, claims and causes of action whether arising at law (by contract or in tort) or in equity in connection with Grantor's past use or the condition of the premises and the past, present or future use and/or the condition of adjacent and nearby lands owned or controlled by it with respect to industrial, mining, mine waste disposal and quarrying operations, and whether such industrial, mining, mine waste disposal and quarrying operations be conducted by Grantor, or by Grantor's successors, assigns, grantees, licensees, contractors, permittees and lessees.

TO HAVE AND TO HOLD the above granted property to said Grantee, its successors and assigns, forever.

AND the Grantor, for itself, its successors and assigns, does hereby covenant with the said Grantee, its successors and assigns, that the property described above is free and clear from all encumbrances whatsoever, created by, from, through or under the Grantor except as stated above, and that said Grantor will forever WARRANT AND DEFEND the same with the appurtenances thereunto belonging, unto the said Grantee, its successors and assigns, against all lawful claims of all persons, claiming by, from, through or under the Grantor herein, except as stated above.
