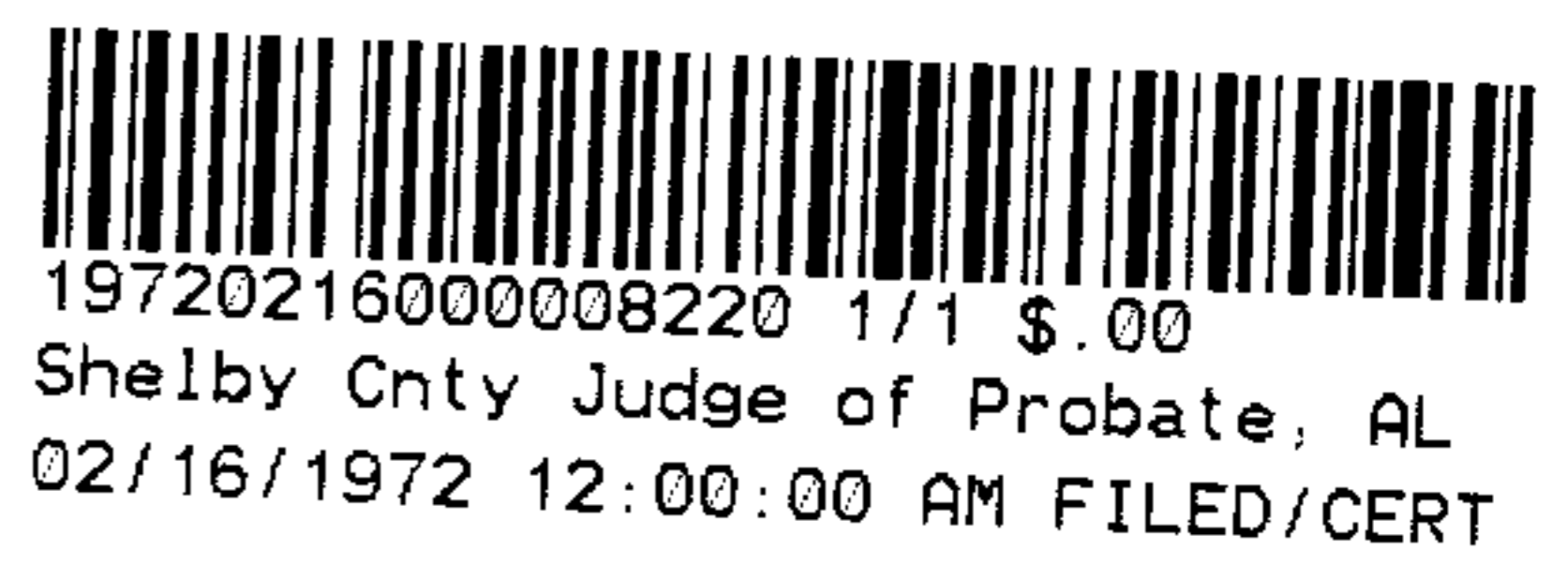
That in consideration of Thirty-one Thousand and No/100 ----- (\$31,000.00) Dollars
