My name is Leola Tolbert. I am 61 years of age and am the daughter of Fannie Byers. I have lived in the Alabaster community all my life and have all along been acquainted with the hereinafter described land:

A part of the NE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 12, Township 21 South, Range 3 West, described as follows: Beginning on the East right of way line of old Birmingham-Montgomery Highway at the NW corner of Daisy Harris property and run Northerly along said Highway right of way 150 feet; thence run Northeast direction to West right of way line of I-65 Highway; thence in a Southerly direction along West right of way line of I-65 to the North line of Daisy Harris property; thence Westerly along North line of Daisy Harris property to point of beginning; situated in Shelby County, Alabama.

There is called to my attention a deed from Mamie Welch to Columbus Lee Hosey and wife, Anna Hosey dated September 8, 1941, and recorded in Deed Book 110 page 437 in the Probate Office of Shelby County, Alabama. Affiant says the said Hosey lot was all taken by the State for the construction of the new Interstate 65 Highway and none of it overlaps the above described land. There is called to my attention a deed from Daisy Harris to me dated September 27, 1954, covering one-half acre, recorded in Deed Book 169, page 32 in said Probate Office. There was an error in the description of said deed and it should have said "Section 12, Township 21, Range 3 West" instead of "Township 12 21 Range 3 West". The lot I bought from Daisy Harris was situated on the East end of the Daisy Harris lot and was all taken by the State for right-of-way for Interstate 65 Highway and said lot from Daisy Harris to me does not interfere with the above described lot.
