WARRANTY DEED

STATE OF ALABAMA:  
JEFFERSON COUNTY:

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Thirty Thousand and no/100 Dollars (\$30,000.00) and the assumption of that certain mortgage from AudioTronics of America, a corporation, to Guaranty Savings & Loan Association, dated December 9, 1970, recorded in the Office of the Judge of Probate of Shelby County, Alabama in Mortgage Book 315, Page 464, and having a present unpaid principal balance of \$44,358.83, to the undersigned grantor, AudioTronics of America, a corporation, in hand paid by Educators' Investment Corporation of Alabama, Inc., the receipt of which is hereby acknowledged, the said AudioTronics of America, a corporation, does by these presents, grant, bargain, sell and convey unto the said Educators' Investment Corporation of Alabama, Inc. the following described real estate, situated in Shelby County, Alabama:

Commence at the SW corner of the NE 1/4 of SE 1/4 of Section 1, Township 20 South, Range 3 West; thence in a Northerly direction along the Westerly line of said 1/4 - 1/4 Section a distance of 523.48 feet; thence 123 deg. 58' to right in a Southeasterly direction a distance of 509.92 feet to the point of beginning; thence continue along last described course a distance of 100.50 feet; thence 95 deg. 42' 30" left in a Northeasterly direction a distance of 350.83 feet; thence 90 deg. left in a Northwesterly direction 100.0 feet; thence 90 deg. left in a Southwesterly direction a distance of 340.84 feet to point of beginning.
