Said land hereby dedicated for said purposes is situated in Shelby County, Alabama, and is more particularly described as follows, to-wit:

A part of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 15, Township 20 S, Range 3 W, more particularly described as follows: Commence at the SW corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ and run North 89 deg. 15 min. East, 325.0 feet to the point of beginning; thence run North 89 deg. 15 min. East, 30.0 feet; thence run North 2 deg. 22 min. East, 550 feet to the South line of the Helena-Pelham Road; thence run North 86 deg. 23 min. West, 30 feet; thence run South 2 deg. 22 min. West, 550 feet to the point of beginning.

The above said parcel of land is dedicated for highway, street and road purposes extending from the Helena-Pelham Road across the above described property to the extreme Southern end thereof.
