H. Kimbrough (herein referred to as grantee), the following described real estate, situated in Shelby County, Alabama, to-wit:

Commence at the southwest corner of the southwest one-fourth of the southeast one-fourth of Section 28, Township 19 south, Range 2 east, Shelby County, Ala., thence proceed N 49° 15' E for a distance of 234.0 feet to the point; thence turn an angle of 38° 45' to the right and proceed N 89° 00' E for a distance of 215.0 feet to the point of beginning. From this beginning point turn an angle of 3° 58' to the right and proceed S 87° 52' E for a distance of 253.66 feet; thence turn an angle of 82° 44' to the left and proceed N 10° 14' E for a distance of 266.3 feet; thence turn an angle of 104° 52' to the left and proceed S 85° 22' W for a distance of 259.94 feet; thence turn an angle of 106° 34' to the left and proceed S 21° 12' E for a distance of 94.16 feet; thence turn an angle of 96° 30' to the right and proceed S 75° 18' W for a distance of 99.3 feet; thence turn an angle of 85° 20' to the left and proceed S 10° 02' E for a distance of 116.74 feet to the point of beginning.
