WHEREAS, there has been presented to the Board of Education of Shelby County, Alabama, a copy of a patent issued by the State of Alabama to A. G. Mabry on November 30, 1861, which was filed for record in the Probate Office of Shelby County, Alabama on June 25, 1914 in Deed Book 55, page 44 in said Probate Office, which conveyed the following land:

The E $\frac{1}{2}$ of the NE $\frac{1}{4}$ with the exception of 5 acres reserved by the Commissioners for a location for a school house of Section No. 16 in Township 21, Range 3 West, containing 75.79 acres, in pursuance of the act entitled "An Act to authorize the sale of 16th Sections and for other purposes" approved 15th January 1828.

WHEREAS, there has also been presented to this Board a copy of affidavits of George M. Harrison executed December 16, 1964, and of Charles Lacey executed December 12th, 1964, which said affidavits state as follows:

"Affiant further says from the time he can first remember there was never any school building situated on any portion of the E $\frac{1}{2}$ of NE $\frac{1}{4}$ of said Section 16. Affiant further says it was common knowledge in the Lacey family and in the community where the above land is located that there had been no school on said property since many years prior to 1880, if ever."

A copy of this affidavit is attached to this resolution;

WHEREAS, the records of said Board do not reveal that said County has ever had a school building on the E $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 16, Township 21, Range 3 West;

Now, therefore, be it resolved by the Board of Education of Shelby County, Alabama, as follows:

That said Board has no record of ever having a school situated on any portion of the E $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 16, Township 21, Range 3 West, Shelby County, Alabama; therefore, said Board does hereby disclaim any interest in and to said land.
