TO WHOM IT MAY CONCERN:

I, the undersigned, hereby certify that Alabama Power Company neither claims the right to nor proposes to construct any future lines for the transmission of electricity over or across the lands described herein below, under the authority granted in the following right of way permits:

1. T. J. Cross and wife, Nannie P. Cross, dated July 8, 1936, recorded in Deed Book 101, Page 511, in the Office of The Judge of Probate of Shelby County, Alabama.
2. Mrs. T. J. Cross, a widow, dated November 12, 1946, recorded in Deed Book 198, Page 303, in the Office of The Judge of Probate of Shelby County, Alabama.

The purpose for which such right of way permits were acquired was for distribution lines that heretofore have been placed on the property of the Grantor other than that described below:

one
A parcel of land which lies within the east half of the southeast quarter (E 1/2 of SE 1/4) of Section 1 Township 20, Range 3 west, Shelby County, Alabama, more particularly described as follows: To reach a point of beginning, commence at the southwest corner of the northeast quarter of the southeast quarter (NE 1/4 of SE 1/4) of Section 1, Township 20, Range 3 west; thence run north along the west boundary line of said quarter - quarter section a distance of 523.48 feet to the point of beginning; thence turn an angle to the right of 123 degrees 58 minutes and run a distance of 1012.42 feet to a point; thence turn an angle to the left of 95 degrees 42 minutes and 30 seconds and run a distance of 831.65 feet to a point; thence turn an angle to the left of 94 degrees 55 minutes 30 seconds and run a distance of 1069.61 feet to a point; thence turn an angle to the right of 90 degrees 00 minutes and thence run a distance of 245.95 feet to a point; thence turn an angle to the left of 112 degrees 34 minutes 30 seconds and run a distance of 348.63 feet to a point; thence turn an angle to the left of 90 degrees 45 minutes 30 seconds and run a distance of 820.93 feet to the point of beginning.


