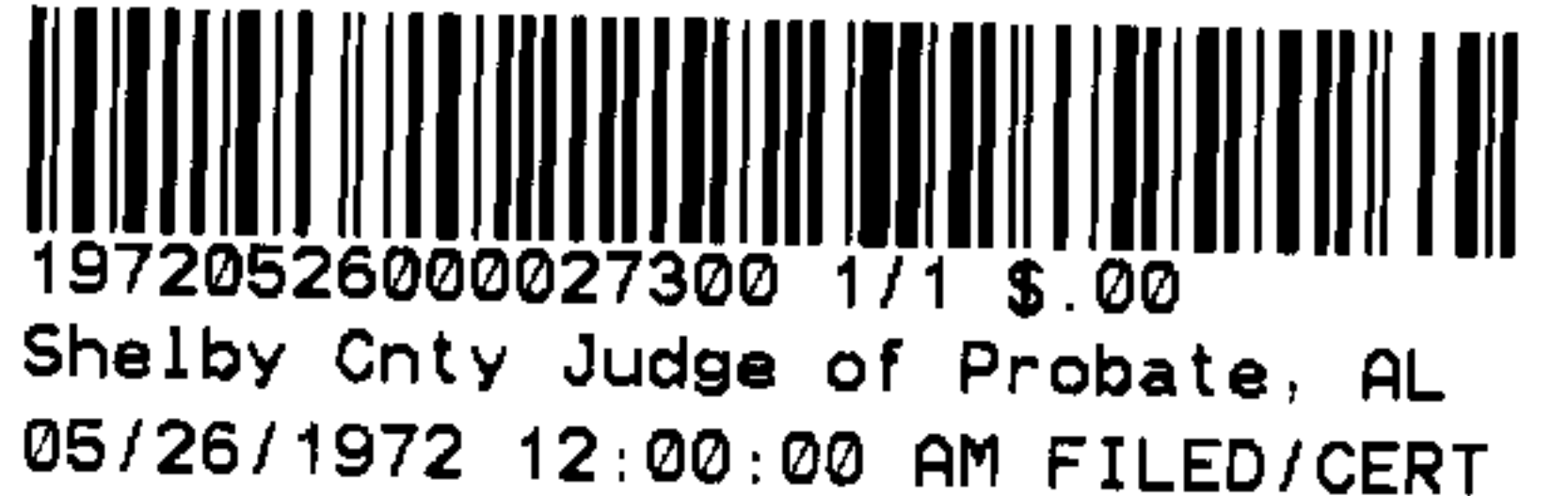

does by these presents, grant, bargain, sell and convey unto the said
Sara E. Palmer

the following described real estate, situated in Shelby County, Alabama, to-wit:

Commence at the northeast corner of Section 27, Township 21 South, Range 1 West and run south 84 deg. 39 min. 30 sec. west a distance of 65.13 feet to a point; thence turn an angle of 86 deg. 23 min. 30 sec. to the left and run south 1 deg. 44 min. east a distance of 485.89 feet to a point; thence turn an angle of 90 deg. to the right and run south 88 deg. 16 min. west a distance of 45.0 feet to the point of beginning; thence turn an angle of 90 deg. to the left and run south 1 deg. 44 min. east a distance of 434.03 feet to a point on the northwest 40' R/O/W line of a County Road; thence turn an angle of 124 deg. 09 min. to the left and run north 54 deg. 07 min. east along said R/O/W line a distance of 406 feet, more or less, to the southwest corner of the Alabama Power Company Substation lot; thence turn an angle of 55 deg. 51 min. to the left and run north 1 deg. 44 min. west along the west boundary line of said Substation lot a distance of 210 feet, more or less, to a point at the northwest corner of said Substation; thence turn an angle of 90 deg. to the left and run south 88 deg. 16 min. west a distance of 320 feet, more or less, to the point of beginning.
