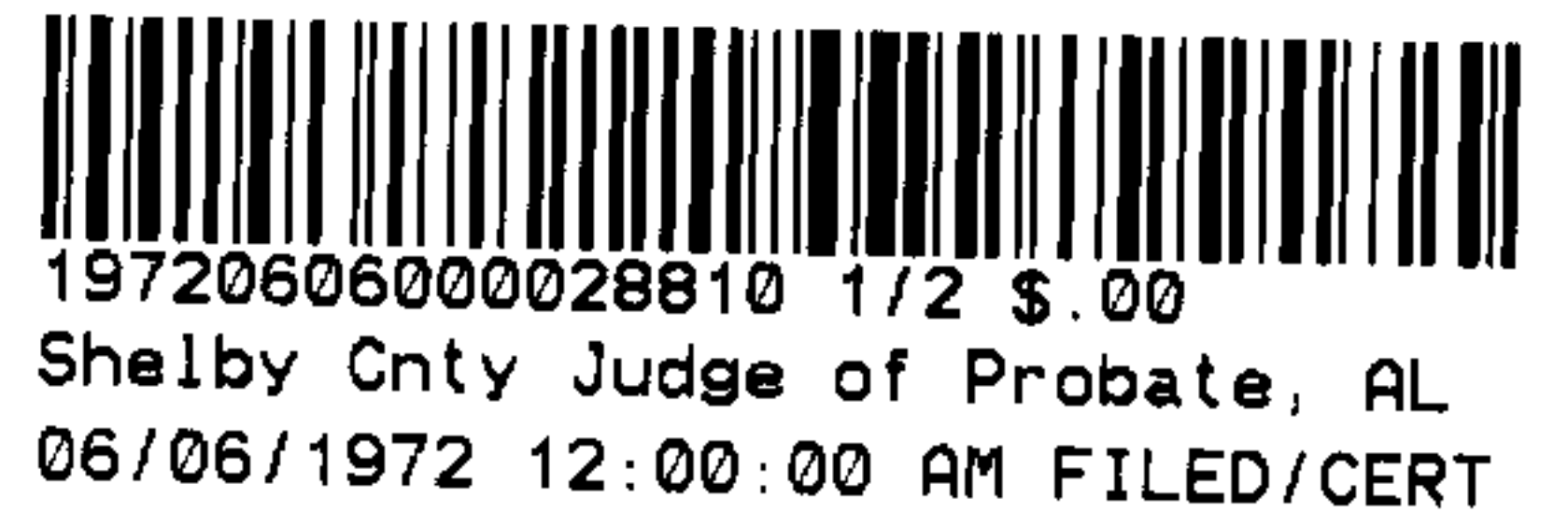

QUIT CLAIM DEED

WHEREAS, Calera Lime Corporation, Inc, a Corporation, has heretofore been dissolved; whereupon, W. J. Mitchell, as a Director was named as Trustee with full power to settle the affairs of said Corporation, to sell and convey property which it still owned at the time of its dissolution, and

WHEREAS, the said W. J. Mitchell is still authorized to act for said Corporation in said capacity;

WHEREAS, on February 15, 1943, Calera Lime Corporation, Inc., a corporation, executed a deed to Coosa Land Company, Inc. covering Lots 17 to 21 Block 267 according to J. H. NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Dollar to Calera Lime Corporation, Inc., a dissolved corporation, in hand paid by Pearl Adams, the receipt whereof is hereby acknowledged, it does remise, release, quit claim and convey to the said Pearl Adams, all its right, title, interest and claim in or to the following described real estate, to-wit:

Lots 19, 20 and 21 in Block 267 according to survey and map of J. H. Dunstan of the Town of Calera, Alabama; being situated in Shelby County, Alabama.

This deed is executed for curative purposes only, as mentioned above.

TO HAVE AND TO HOLD to the said Pearl Adams, her heirs and assigns forever.
