Jesse M. Higginbotham and Emma Dell Higginbotham

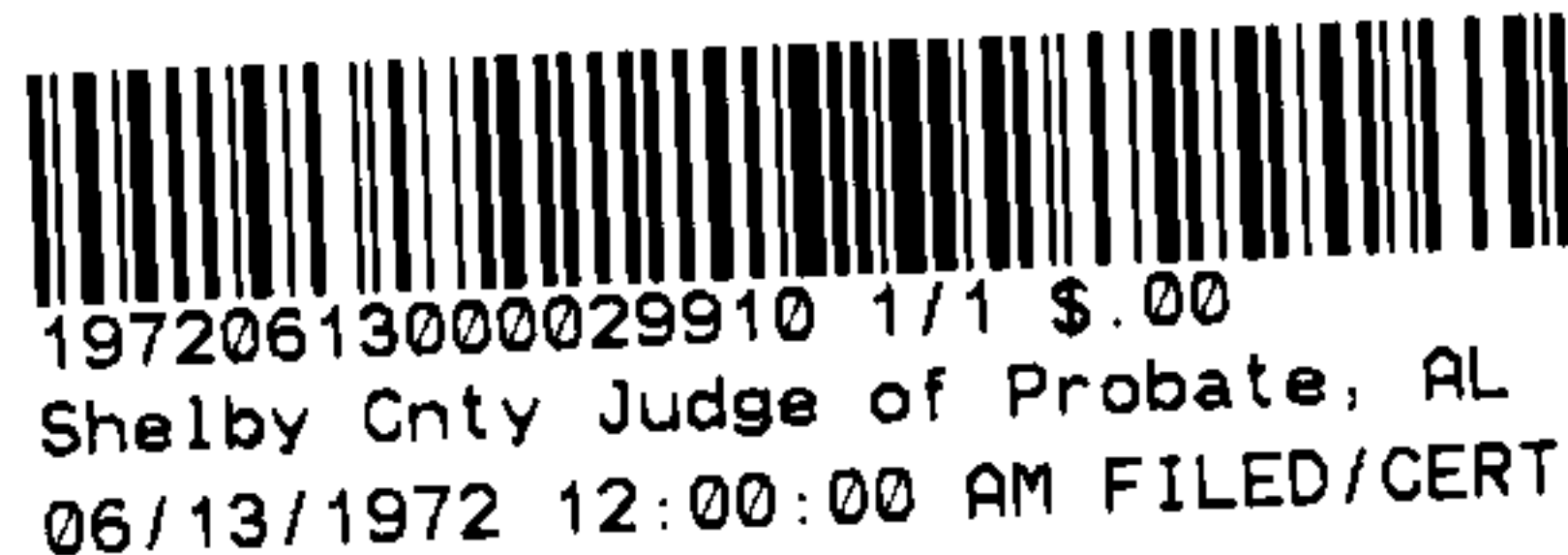
(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
