KNOW ALL MEN BY THESE PRESENTS, that the undersigned SOUTHERN ELECTRIC GENERATING COMPANY, a corporation, for and in consideration of the sum of Two thousand seven hundred thirty three (\$ 2,733.25) to it in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain electric transmission and communication lines and all towers, poles, conduits, conductors, cables, insulators, anchors, guy wires, counterpoise conductors, and all other appliances necessary or convenient in connection therewith, from time to time, over, under and across two strips of land one hundred twenty five (125) feet in width, as said strips are now located by the final location survey thereof heretofore made by said Company, over, under and across the lands of which they are herein-after described as being a part, said survey to determine the boundaries of said strips, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strips and the right to cut, remove, or otherwise kill, and keep clear by any means, including chemicals, all trees and undergrowth and all other obstructions under, on or above said strips and danger trees adjacent thereto which now or may hereafter injure, endanger or interfere with any of the works on said strips, and the right to install, maintain and use anchors and guy wires on land adjacent to said strips.

Said strips are a part of a tract of land situated in Shelby County, Alabama, described as follows:

South half of northwest quarter ($S\frac{1}{2}$ of $NW\frac{1}{4}$) and northeast quarter of the southwest quarter ($NE\frac{1}{4}$ of $SW\frac{1}{4}$) of Section 32, Township 20 south, Range 2 east.

Said strips are approximately described as follows:

Strip One

To reach a point of beginning, commence at the northeast corner of Section 31, Township 20 south, Range 2 east; thence run west along the north boundary line of such Section 31 a distance of 339.4 feet to a point; thence turn an angle to the left of 128 degrees 37 minutes and run south 36 degrees 54 minutes east a distance of 1699 feet, more or less, to a point on the north boundary line of the Grantor's property, such point being the point of beginning of the first strip of right of way herein described; therefrom, the strip lies 62.5 feet on each side of a center line and the continuations thereof which begins at such point of beginning and runs south 36 degrees 54 minutes east a distance of 1530 feet, more or less, to a point on the northwesterly waters edge of Lay Lake, such point being called point "A" for reference hereinafter and the point of ending of strip number one herein described.

Strip Two

To reach the point of beginning, commence at point "A" referred to in the description of strip number one next above, and continue south 36 degrees 54 minutes east a distance of 378 feet, more or less, to a point on the southeasterly waters edge of Lay Lake, such point being the point of beginning of the second strip of right of way herein described; therefrom, the strip lies 62.5 feet on each side of a center line and the continuations thereof which begins at such point of beginning and runs south 36 degrees 54 minutes east a distance of 442 feet, more or less, to a point on an existing Alabama Power Company Right of Way, such point being the point of ending of strip number two herein described.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever, except as herein provided.


The grantor shall have the right to use said strip of land for any purpose not inconsistent with the rights which the grantee may from time to time exercise hereunder.


