

That in consideration of Forty one thousand five hundred and no/100 --(41,500.00)-- Dollars

to the undersigned grantor, WEB Homebuilders, Inc. a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant bargain, sell and convey unto Robert A.
