KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One Dollar and other good and valuable consideration to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Annie Nell Howard and husband, Robert Howard, Benny Allen and wife, Louise Allen, G. Allen and wife, Valera Allen, James Allen and wife, Luvenia Allen and Litha Allen, a widow (herein referred to as grantors) do grant, bargain, sell and convey unto Curtis G. 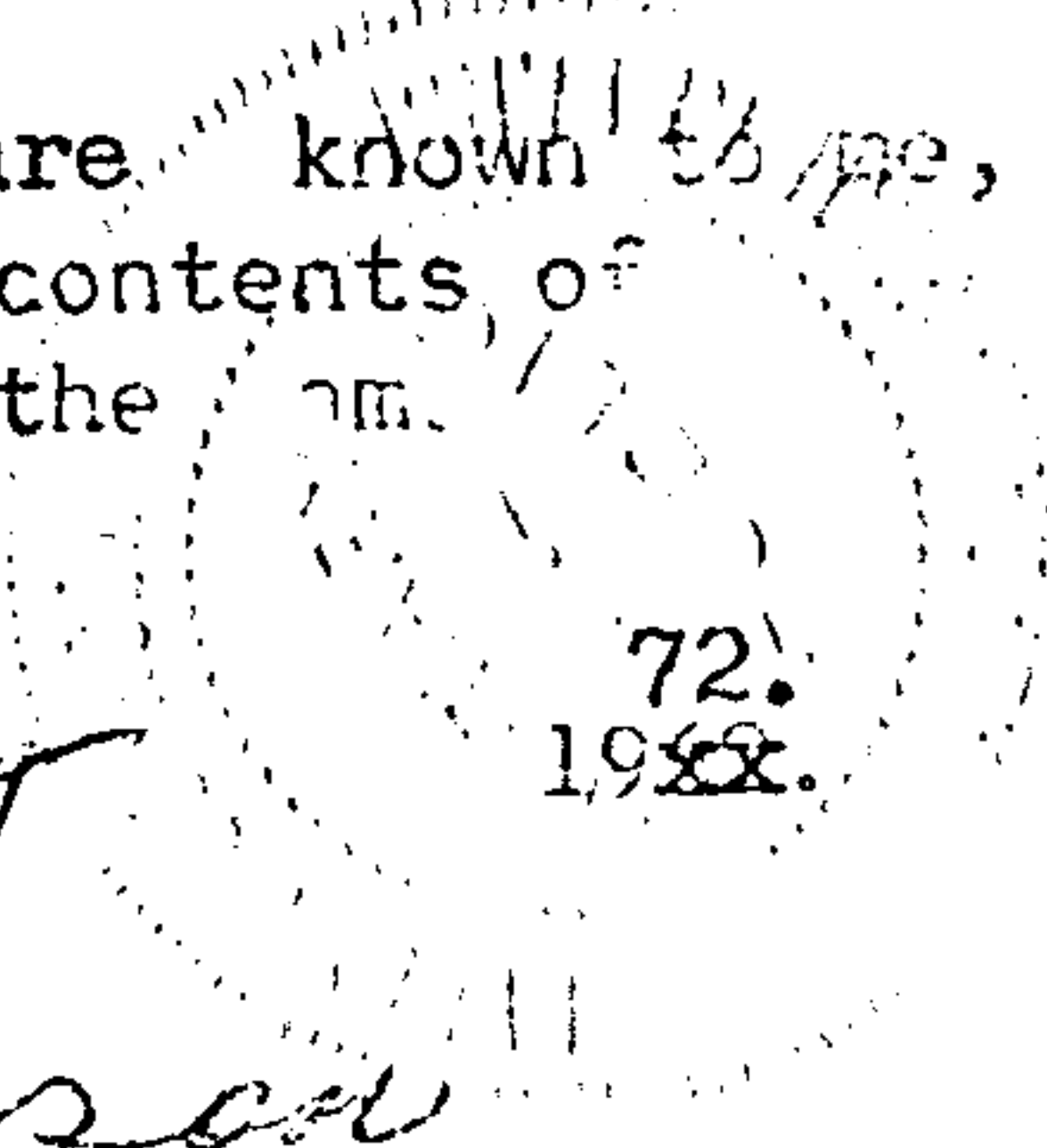
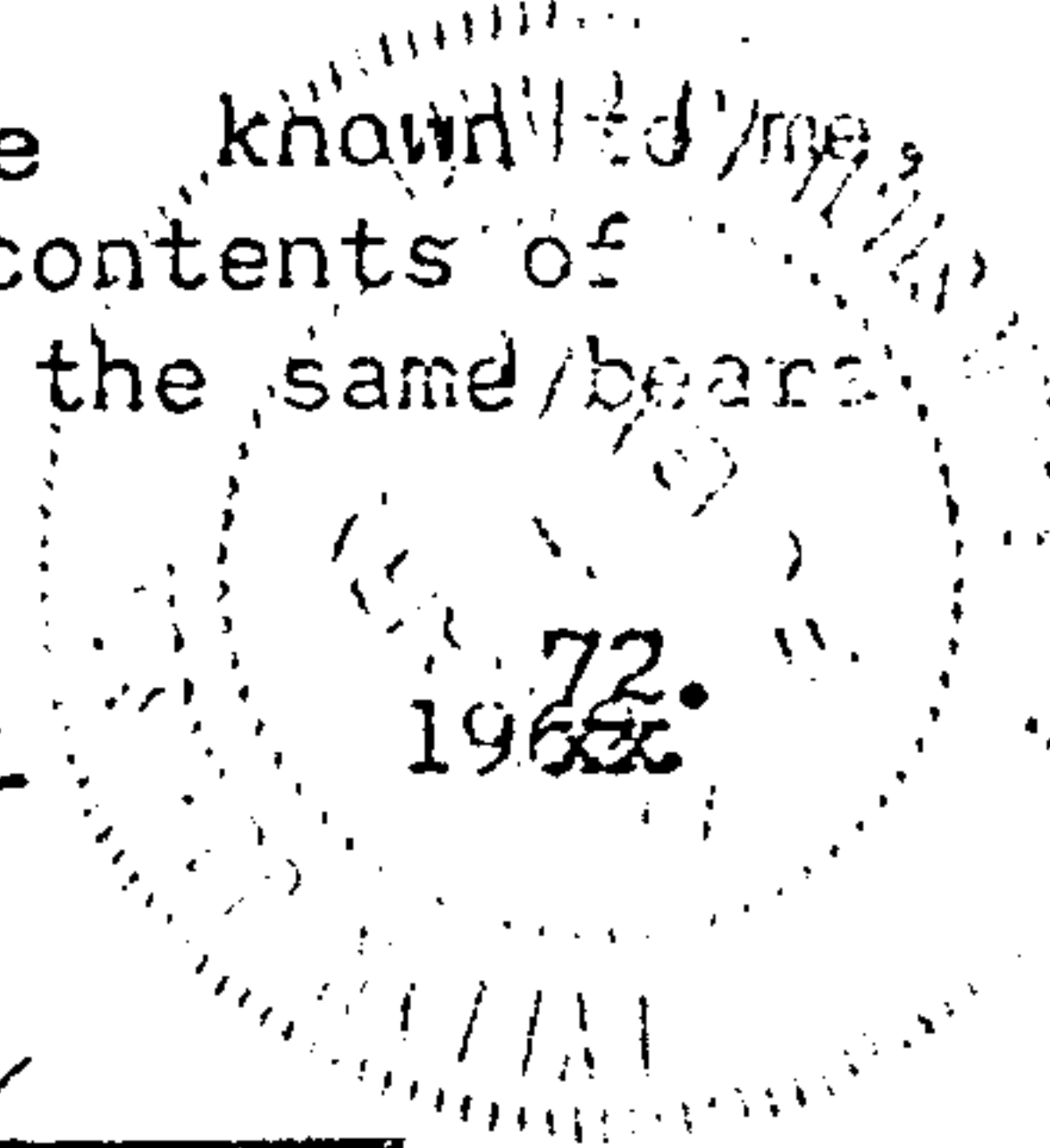
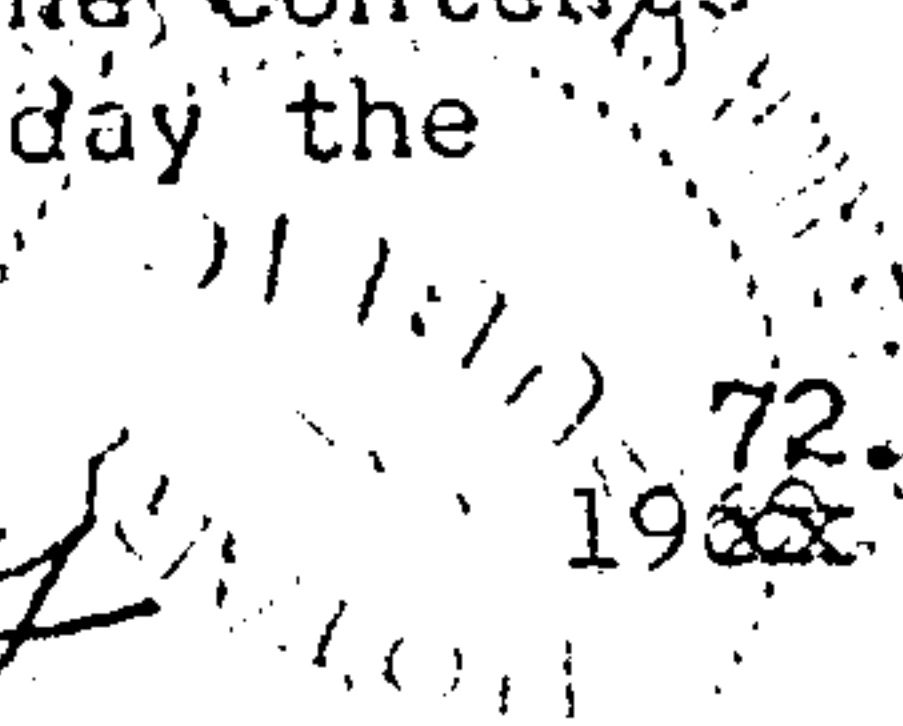
