(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated

in Shelby County, Alabama to-wit:

A part of the NE 1/4 of the NE 1/4 of Section 16, Township 21 South, Range 3 West described as follows: Commence at the NW corner of said 1/4-1/4 section and run southerly along the West boundary line of said NE 1/4 of the NE 1/4 for 420.0 feet; thence run easterly parallel to the north boundary line of said 1/4-1/4 section for 450.0 feet to the point of beginning of the land herein described; thence continue easterly parallel to the north line of said 1/4-1/4 section 382.25 feet; thence run southerly parallel to the west boundary line of said 1/4-1/4 section for 113.96 feet; thence westerly parallel to the north boundary line of said 1/4-1/4 section for 382.25 feet; thence run northerly 113.96 feet to the point of beginning.
