WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR-

SHELBY COUNTY } KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

R. C. Trimm and wife, Helen Trimm
(herein referred to as grantors) do grant, bargain, sell and convey unto

Thomas A. Hendrix and Ruth G. Hendrix
(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Begin at the southeast corner of the NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 3, Township 22 South, Range 2 West and run thence west along the south line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 183.0 feet to an iron pipe; thence turn an angle of 131 deg. 26 min. to the right and run northerly to the south right-of-way line of County Highway; thence turn an angle of 91 deg. 13 min. to the right and run easterly along the south right-of-way line of said Highway a distance of 277.8 feet to an iron pipe; thence turn an angle of 95 deg. 36 min. to the right and run southwesterly a distance of 211.2 feet to an iron pipe; thence turn an angle of 80 deg. 16 min. to the right and run westerly a distance of 66.8 feet to the west line of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of said Section 3; thence run north along the west line of said SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of said Section 3 to the point of beginning of the lot herein described.
