

## RIGHT-OF-WAY DEED FOR PUBLIC ROAD

STATE OF ALABAMA

Shelby County

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, \_\_\_\_\_

\_\_\_\_\_ and wife \_\_\_\_\_ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be \_\_\_\_\_ see below \_\_\_\_\_ feet in width on \_\_\_\_\_ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a \_\_\_\_\_ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project CP4-151 as recorded in the office of the Judge of Probate of Shelby County.

Commence at the southeast corner of the NW $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 33, T 18 S, R 2 E and run north along the east boundary of said quarter quarter section a distance of 63.0 feet to the point of beginning on the southwest 40 foot right of way of Project CP4-151; thence continue along said boundary a distance of 610.0 feet to a point on the northwest 40 foot right of way line of said project; thence run southwesterly along said right of way along a curve to the left (concave southeasterly) and having a radius of 756.20 feet a distance of 459.0 feet to a point 40.0 feet left of P. C. Station 93+53.9; thence run S 13° 08' E along said right of way a distance of 152.0 feet to the point of beginning.

Said parcel of land is lying in the NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 33, T 18 S, R 2 E and contains 0.47 acres, more or less, including that part now occupied by the present dirt road.

All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
