WARRANTY DEED

That in consideration of One Thousand and no/100 Dollars and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt whereof is acknowledged, we, A. C. Collins, Jr. and wife, Annie Lee Collins; Hallie Cohill and husband, Paul Cohill, Jr.; Sammy Collins, Jr., unmarried; Beatrice Threat and husband, Harvey Threat; Louisiana Horn, a widow; and being one and the same as Nell V. Collins, Vinnie Collins, a widow (herein referred to as grantor), grant, bargain, sell and convey unto Jerry O. Lorant (herein referred to as grantee), the following described real estate, situated in Shelby County, Alabama, to-wit:

The $\frac{1}{2}$ of the $\frac{1}{4}$ of Section 3, Township 21, Range 3 West, except the following two tracts of land:

A parcel of land situated in the $\frac{1}{4}$ of the $\frac{1}{4}$ of Section 3, Township 21 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows: Commence at the Northeast corner of the $\frac{1}{4}$ of the $\frac{1}{4}$ of Section 3, Township 21 South, Range 3 West; run thence in a Westerly direction along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ section for a distance of 349.29 feet; thence turn an angle to left of 61 deg. 42 min. 18 sec. and in a Southwesterly direction for a distance of 193.70 feet; thence turn an angle to the left of 109 deg. 53 min. 45 sec. and in a Southeasterly direction for a distance of 453.16 feet to its intersection with the East line of the $\frac{1}{4}$ of the $\frac{1}{4}$ of said Section 3, thence turn an angle to the left of 100 deg. 08 min. 45 sec. and in a Northerly direction along said East line for a distance of 236.84 feet to the point of beginning. Said site contains 1.8966 acres.

Part of the $\frac{1}{4}$ of the $\frac{1}{4}$ of Section 3, Township 21 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows; Begin at the Northwest corner of the $\frac{1}{4}$ of Section 3, Township 21 South, Range 3 West; run thence in an Easterly direction along the north line of said quarter-quarter section for a distance of 937.56 feet; thence turn an angle to the right of 119 deg. 41 min. 30 sec. and in a Southwesterly direction for a distance of 194.15 feet; thence turn an angle to the right of 71 deg. 38 min. 30 sec. and in a Northwesterly direction for a distance of 858.12 feet to the point of beginning. Said site containing 1.6123 acres.
