THIS AGREEMENT, made this the 5th day of December, 1972, by and between Karl Nickerson, Executor of the Estate of K. B. Nickerson, deceased, Karl Nickerson and wife, Claire Nickerson, Paul Nickerson ^{a widower} ~~and wife, Rachel Nickerson~~ and Lois S. Nickerson, a widow, hereinafter referred to as Grantors, and City of Alabaster, a municipal corporation, of Shelby County, Alabama, hereinafter referred to as Grantee:

WITNESSETH, THAT,

WHEREAS, it is determined by the grantors that the granting of the hereinafter described land to the Grantee will be advantageous and to the best interest of the Grantors and will afford to the Grantors and their successors in title a more useful and satisfactory street to serve the Grantors' land adjoining the property herein conveyed.

NOW, THEREFORE, in consideration of One and no/100 Dollars and other good and valuable consideration, the Grantors do hereby grant unto the Grantee a permanent easement for a right of way over and across the hereinafter described land for the construction and maintenance of a public street, avenue or public thoroughfare. Said right of way herein granted being more particularly described as follows:

A strip of land 23 ft. wide of uniform width lying adjacent to and extending along the entire North side of Lots 8 and 16 as shown by Nickerson's Survey on Helena Road which Survey is in Section 2, Township 21, Range 3 West as shown by map recorded in Map Book 3, page 116 in the Probate Office of Shelby County, Alabama.

TO HAVE AND TO HOLD the same unto the said Grantee and its assigns for the uses and purposes for which said land is granted, so long as said land is used by the Grantee or its assigns as a public street, avenue or public thoroughfare.
