Begin at the SE Corner of the SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 34, Township 19, Range 2 East; thence South 85 deg. 30 min. West 1125.8 feet to the center of Chancellor's Ferry Road; thence along the center of said road North 34 deg. 30 min. West 1029.0 ft.; thence South 55 deg. 30 min. West, 30.0 ft. to the Western line of the right of way of said Chancellor's Ferry Road to a point; thence North 34 deg. 30 min. West, 72 ft.; thence South 46 deg. 10 min. West 150 ft.; thence South 34 deg. 30 min. East, 87 ft. for the point of beginning of the lot herein conveyed; thence South 34 deg. 30 min. East 75 ft.; thence North 46 deg. 10 min. East, 50 ft.; thence North 34 deg. 30 min. West 75 ft.; thence South 46 deg. 10 min.
