WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR-LAWYERS TITLE INSURANCE CORPORATION, Birmingham, Alabama

STATE OF ALABAMA SHELBY

KNOW ALL MEN BY THESE PRESENTS.

That in consideration of one and other good and valuable considerations

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Maria B. Campbell, a single woman and William A. Yon, joined herein by his wife, Elizabeth M. Yon

(herein referred to as grantors) do grant, bargain, sell and convey unto

Philip Mohring and his wife, Hunter Mohring

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated Shelby County, Alabama to-wit:

A parcel of land lying partially in the SE-1/4 of the SW-1/4 of Section 35, Township 19 South, Range 1 West of the Huntsville principal meridian, and partially in the NE-1/4 of the NW-1/4 of Section 2, Township 20 South, Range 1 West of the Huntsville principal meridian, being more particularly described as follows:

Beginning at the SW corner of the said SE-1/4 of the SW-1/4 section being also the NW corner of the said NE-1/4 of the NW-1/4 section run north along the west line of the said SE-1/4 of the SW-1/4 section a distance of 450 feet; thence turning an angle of 110 degrees to the right a distance of 480 feet; thence turning an angle of 70 degrees to the right a distance of 550 feet to a point in the center line of the Shelby County gravel road; thence in a southwesterly direction and a northwesterly direction along the center line of said gravel road a distance of 520 feet more or less to the intersection with the west line of the said NE-1/4 of the NW-1/4 section; thence north along the west line of the said NE-1/4 of the NW-1/4 section a distance of 230 feet to the point of beginning; containing 7.06 acres.

This conveyance is made subject to the line of that certain mortgage executed by the Grantors herein in favor of the Mattie Lou Hodge, dated June 30, 1972 and recorded in the Office of the Judge of Probate of Shelby County, Alabama in Mortgage Book 323 at Pages 704 , and to all recorded liens, easements, restrictions and covenants.

TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And K (we) do for kx x k (ourselves) and for kx (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that XXXXX(we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that k (we) have a good right to sell and convey the same as aforesaid; that k (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever. against the lawful claims of all persons.
