

## EXHIBIT "A"

A part of the NE% of the NW% and part of the NW% of the NE% of Section 35, Township 21, Range 3 West, more particularly described as follows: Commence at the point where the Northern boundary of the NW% OF THE NE% OF Section 35 is intersected by the Westerly right of way line of the Montevallo-Siluria Highway; run thence in a Southwesterly direction along the Westerly right of way line of said Highway a distance of 436.00 feet, more or less, to a point, which said point is the Southeastern corner of the Dorothy D. Ervin and Reese E. Ervin property, for point of beginning; thence turn to the right and run Westerly parallel with the northern boundary of said NW% OF NE% and parallel with the Northern boundary of the NE% of the NW4 a distance of 2,000.00 feet, more or less, to a point on the Western 14-14 section line of the said NE4 of NW4 which said point is also the Southwestern corner of the Dorothy D. Ervin and Reese E. Ervin lot; thence turn to the left and run Southerly along the Western boundary of said 1/4-1/4 section a distance of 440 feet to a point; thence turn to the left and run Easterly parallel with the Northern boundary of the NE% of the NW% and parallel with the Northern boundary of the NW4 of the NE4 a distance of 1,900 feet, more or less, to a point on the Westerly right of way line of the Montevallo-Siluria Highway; thence left and run in a Northeasterly direction along the Western right of way line of said Highway addistance of 439 feet, more or less, to point of beginning.
