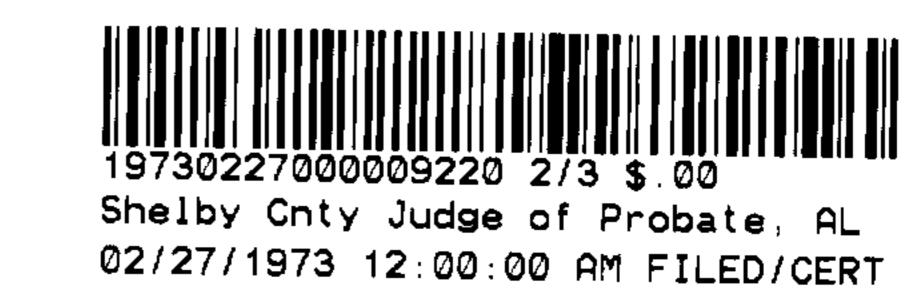

TO HAVE AND TO HOLD to the said grantee, his heirs and assigns forever.

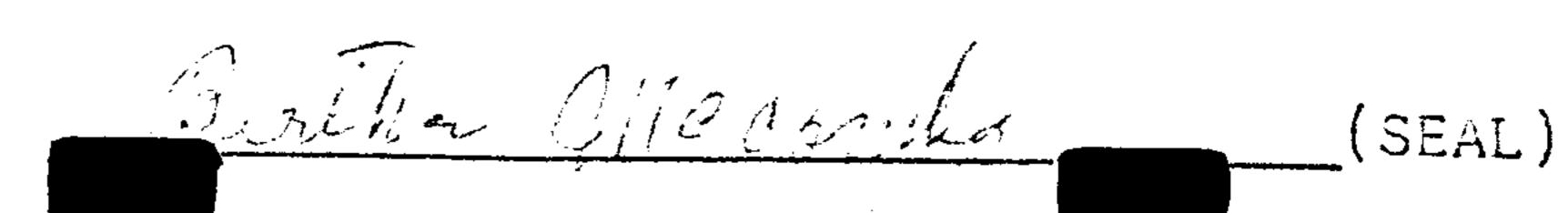

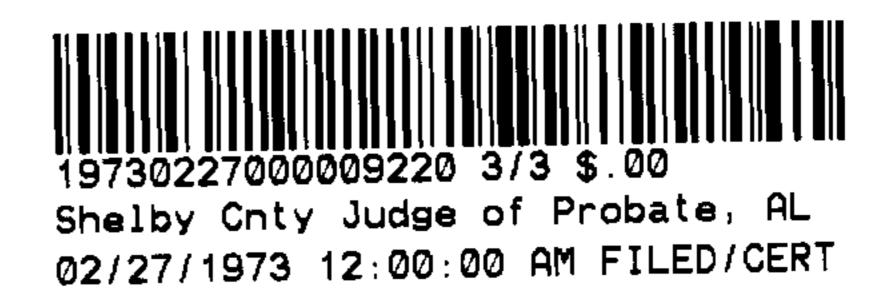
