County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County, Alabama the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, Alabama, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be twenty-five feet in width on each side of the center line of said road, as it is now located and staked out ~~by the State Highway Department~~ or as much of our lands as is required to make a fifty foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit:
